# What is it?

The Emergency Food Assistance Program was established in 1981 to increase food availability to at risk populations experiencing hunger. Nearly 100 God's Pantry Food Bank agency partners participate in distributions in their areas.

The US Department of Agriculture purchases and distributes foods at no cost to food banks and feeding organizations nationwide.

Available foods are nonperishables such as canned and boxed items like canned and frozen vegetables, rice, beans as well as canned and frozen beef, chicken, pork and fish.

In Kentucky, God's Pantry Food Bank and other food banks across the commonwealth receive USDA foods the Kentucky Department of Agriculture.



# TEFAP Allocations

All USDA foods in the TEFAP program are allocated according to county population, unemployment and poverty statistics to determine the allowance for each county.

This is updated every 6 months to a year to reflect changes in the measures used to set the allocations.

Pantries in any given county will divide the county's allocations between them. The amount sent to each will reflect your number of households and participants served. As your household numbers change your allocation may be altered to help you serve your neighbors.



To find the allocation list, go to the Agency Resources link at the top left of the God's Pantry home page.

When you scroll down the page you will see buttons on the left side of the screen.

Select "Commodity Allocations and Postings".



# Allocation Sheets

When placing an order for TEFAP items, you must check the allocation tables posted on our website.

Each item is listed by county, pantry name and number of cases allotted.

You may order from each allocation sheet once and once only. Each allocation is separate from all others.

If the same item is posted twice, you may order from both postings.

Each post is a link that will open the sheet on your device.

# Income Guidelines and Information Requirements

USDA commodities programs have income requirements that are to be met by participants in the program.

These guidelines are updated each year to reflect changes in costs of living.

Participants must be at or below the income guidelines for their household.

This is self reported. Providing proof of income is not required.

You or a volunteer may fill out the information at the top. Each head of household must be shown this and attest that they meet the income qualifications.



# Income Guidelines and Information Requirements

All records that pertain to the TEFAP program must be kept for three years. You may keep these records in paper or electronic form.

The TEFAP Commodity Register provides the basic information required for each participant. Their name and the number of persons in the household is all that is required. You should have this information for every time you have a distribution of TEFAP foods.
