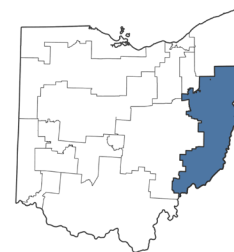

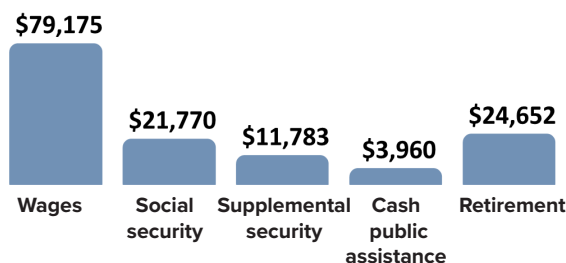

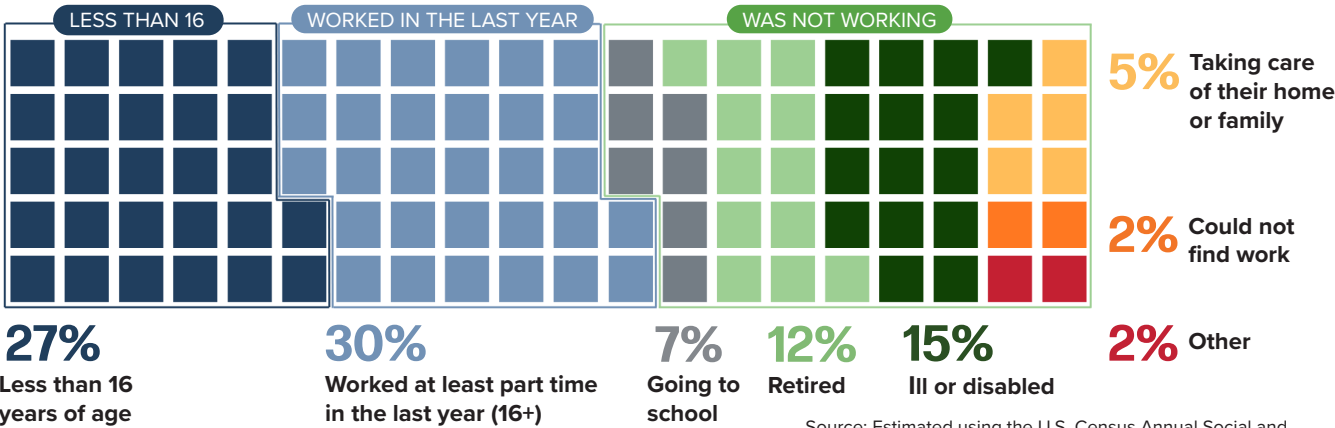

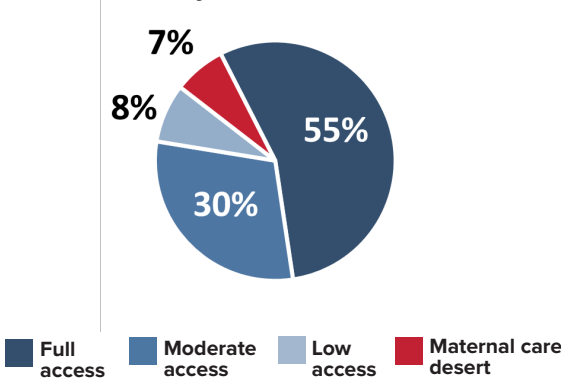

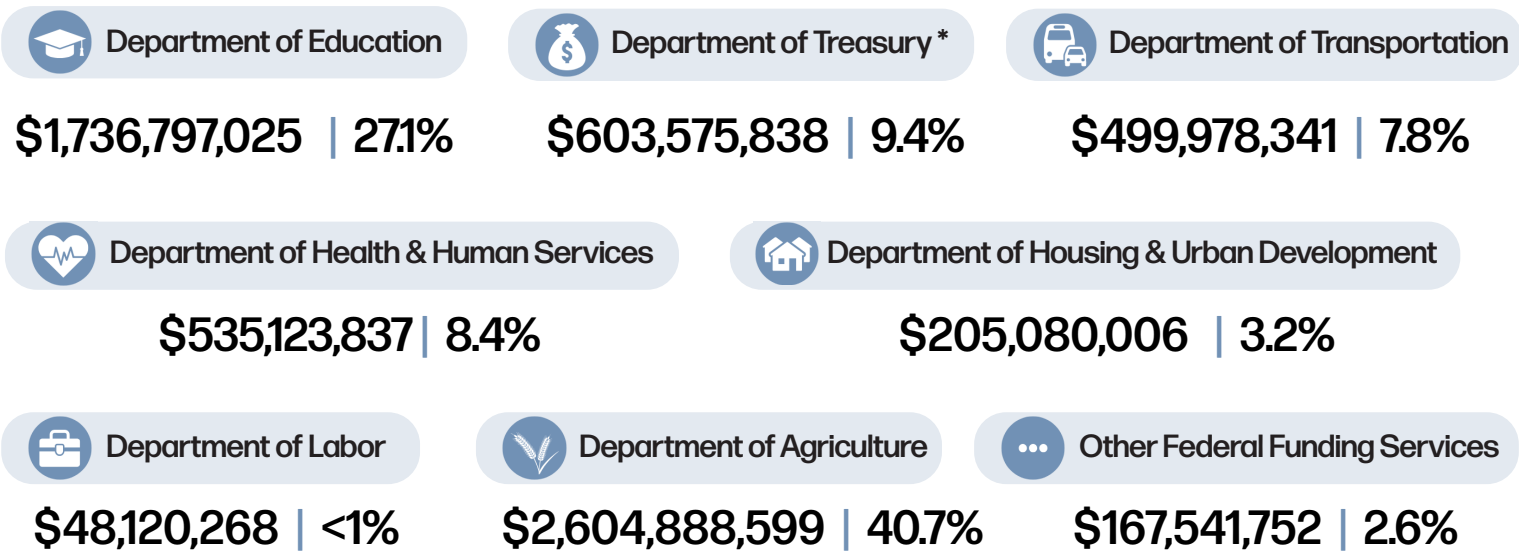

About these Fact Sheets

These Fact Sheets for Ohio's fifteen Federal Congressional Districts were developed in Spring 2025 using multiple publicly available data sources. All data should be interpreted as estimates. There will always be some level of error in large estimations of any data.

The primary source was the U.S. Census Bureau's 2023 American Community Survey 5-year estimates. Additional sources included: the Ohio Department of Medicaid's Who We Serve Dashboard; USASPENDING.gov; Feeding America's Map the Meal Gap; the Census Bureau's Annual Social and Economic Supplements; and the March of Dimes' Maternity Care Deserts Across the U.S. report.

Because not all data were available at the congressional district level, some estimates required apportionment. For federal spending and the March of Dimes data, county-level estimates were apportioned into districts. For counties that were split by districts (13 of 88 counties were split), populations were divided using census tract data. When tracts were split, apportionment was based on the percentage of tract area within each district. For Medicaid data, ZIP code-level estimates were apportioned using the Missouri Census Data Center's Geographic Correspondence Engine.
