

GENERAL INFORMATION: This blend contains a unique Boron blend for use in all crops that benefit from plant available Boron. This formulation is designed for soil and foliar applications. It is also designed to work in all soil types and conditions. Apply it as a band in the soil or inject it through drip or micro-sprinkler systems or boom sprayer applications. Application rates will vary depending on soil tests and crop nutrient demands.

For general applications: Apply 250 - 1240 mL of product in a minimum of 95 L of water per hectare (equivalent to 100-500 mL in 10 gallons of water per acre). Do not exceed more than 2 applications per growing season.
