**GENERAL INFORMATION:** Vantage Ag - Nitrogen is a unique formulation for use when plant available nitrogen is deficient or low, based on soil and/or tissue samples. It should be used as part of a comprehensive nutrient plan for plant growth, development, yield and quality.

**DIRECTIONS FOR USE:** This highly bio-available formulation is designed for foliar applications but can also be applied as a band in the soil or injected through drip or micro-sprinklers. It will work in all soil types and conditions. This formulation can be used on a wide range of crops. Apply Vantage Ag - Nitrogen using recommended rates and directions with your nitrogen management plans.

**APPLICATION RATES:** Foliar applied: Apply 250 - 1240 mL of product in a minimum of 95 L of water per hectare (equivalent to 100-500 mL in 10 gallons of water per acre). Repeat as needed. Soil applied: Apply 490 - 2470 mL of product per hectare (equivalent to 200 mL - 1 L per acre) in furrow. Do not apply to seed.

**COMPATIBILITY:** This product will mix with other products but always conduct a jar test first. Order of mixing; fill sprayer tank to 1/2 full, add pesticide, continue to fill tank and agitate. When tank is 3/4 full, add nitrogen to the tank last.

**STORAGE:** CORROSIVE. Protect from freezing, product will become inactive. Store in a cool dry place.

**CAUTION: CORROSIVE.** Do not eat, drink or smoke while using this product. Wear protective gloves and clothing and eye, face protection and a NIOSH approved N95 respirator. Wash hands thoroughly with soap and water after handling. Avoid release into aquatic environments and do not pour down drains.

**FIRST AID MEASURES:** If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse. If in eyes: Remove contact lenses if present and easy to do so and flush with running water for at least 15 minutes while holding eyelids open. Get medical attention.
