GENERAL INFORMATION: Vantage Ag - Phosphate is a unique formulation for use when plant available phosphate is deficient or low, based on soil and/or tissue samples. It should be used as part of a comprehensive nutrient plan for plant growth, development, yield and quality.

DIRECTIONS FOR USE: This highly bio-available formulation is designed for foliar applications but can also be applied as a band in the soil or injected through drip or micro-sprinklers. It will work in all soil types and conditions. This formulation can be used on a wide range of crops. Apply Vantage Ag - Phosphate using recommended rates and directions with your phosphate management plans.

APPLICATION RATES: Foliar applied: Apply 250 – 870 mL of product in a minimum of 95 L of water per hectare (equivalent to 100–350 mL in 10 gallons of water per acre). Repeat as needed. Soil applied: Apply 310 – 1090 mL of product per hectare (equivalent to 125–440 mL per acre) in furrow. Do not apply to seed.

COMPATIBILITY: This product will mix with other products, but always conduct a jar test first. Order of mixing; fill sprayer tank to 1/2 full, add pesticide, continue to fill tank and agitate. When tank is 3/4 full, add Phosphate to the tank last.

CAUTION: CORROSIVE. Do not eat, drink or smoke while using this product. Wear protective gloves and clothing and eye, face protection

and a NIOSH approved N95 respirator. Wash hands thoroughly with soap and water after handling. Avoid release into aquatic environments and do not pour down drains.

STORAGE: CORROSIVE. Protect from freezing, product will become inactive. Store in a cool dry place.
