Membership Tiers and Fees

1 Background

To cover administrative costs and ensure fairness across different organisation sizes, SCBF has established four membership tiers with corresponding fees and in-kind contributions. These in-kind contributions take the form of expert days, where members contribute a defined number of expert days to support the successful running of SCBF as a member association.

2 Member Tiers – Fees and In-Kind Contribution Days

Tier 1 – Small	For small organisations	CHF 300 annual	5 expert days per

Tier 2 – Mid-size	For organisations with	CHF 500 annual	7 expert days per

Tier 3 – Large	For organisations with	CHF 1,000 annual	10 expert days per
organisations	more than 50 staff	membership fee	year

If, during the course of an organisation's membership, its size or scope changes such that it qualifies for a higher membership fee, the member organisation will inform SCBF accordingly.

2.1 Strategic partner - Tier 4

The Strategic Partners tier is an optional status designed for institutions committed to long-term collaboration and strategic engagement in SCBF's mission. Members at this level benefit from:

- **Co-creation facilitation**: Structured opportunities to jointly develop new initiatives aligned with shared priorities, including joint funding and implementation partnerships.
- Access to larger grants: Ranging from CHF 150k to 300k (compared to the current grant ceiling of CHF 150k).
- Governance participation: A seat on an advisory committee that contributes to SCBF's strategic direction, with the group collectively represented by one member on the Board.
- **Enhanced visibility**: Prominent recognition across SCBF's website, webinars, and annual events.

2.2. In-Kind Contributions

The available expert days are coordinated by the SCBF Secretariat. As part of the aforementioned membership in-kind days, members contribute with the following tasks:

- Providing pre-quality checks as "peer-to-peer" reviews on incoming proposals;
- Assessing project proposals as part of project committees;
- Project monitoring of assigned projects, including review and approval of a final case study report;
- Contributing to knowledge and insights sharing;
- · Participation in the annual General Assembly meetings;
- And other strategic and administrative tasks in close coordination with the Secretariat.

This membership tier system is effective as of January 1, 2026.
