We may also collect information you do not directly provide such as information about the device you use to connect to the sites (including but not limited to behavioral biometrics related to your use of the device for identity verification, fraud avoidance, and security purposes) the type of operating system and internet browser utilized, and information obtained from cookies or other technology that have been placed on your device. We may supplement the information we receive about you from other sources.

### We collect various types of information, including:

- Personal Information: This includes your name, address, email, phone number, Social Security number, and financial information you provide when you open an account or use our services.
- Non-Personal Information: Non-Personal Information: We may collect non-personal information about your visit to our website, including your IP address, browser type, pages visited, and the time spent on each page. This also includes behavioral biometrics related to your use of the device for identity verification, fraud avoidance, and security purposes. Behavioral biometrics may involve analyzing patterns in your interactions with our services, such as typing speed, mouse movements, and touch pressure.
