#### Case Study 01

## Platform Fabric Maintenance Client: Santos (Oil Search PNG)

PANMARINA mobilised to perform an annual maintenance campaign for the Santos Kumul Marine Terminal. Our team provided Engineering, Procurement, Onshore and Offshore Fabcrication, Installation and QA/QC. The project group worked closely with the Client and participants to accurately capture Must-Do items and perform the requisite offshore works. Our team was noted by the Client for their outstanding offshore safety record and no loss-time incidents. ## Pipeline Beach Pull & Installation

Client: Oceania Offshore for Spiecapag

PANMARINA project personnel which formed the offshore execution team for Oceania Offshore delivered a successful beach-pull installation of a tailings pipeline on a remote island of Papua New Guinea. This involved the laying of a 1000mm diameter 580m long HDPE pipe, engineered and fitted with concrete ballast blocks to a water depth termination of 135m. Our project personnel were able to execute this project ahead of schedule, on-budget and safely.

#### Subsea Flowline Installation

Client: Oceania Offshore for Masriah Oil

PANMARINA personnel formed the offshore execution team for Oceania Offshore which was engaged in multiple Subsea Flowline projects for Masriah Oil Limited in Oman. Over several projects our team installed over 2kms of subsea flowline with engineering services provided by PANMARINA.
