

# **Privacy Policy (GDPR)**

## www.infinite-force.com

This Privacy Policy explains how personal data is processed in connection with the use of the website www.infinite-force.com, in particular by persons registering and making payments for participation in "Infinite Force Camp 2026", as well as by persons contacting the Organizer.

#### 1. Data Controller

The data controller is Stowarzyszenie Infinite Force with its registered office in Gdańsk, Chwaszczyńska 9/1, 80-871 Gdańsk, Poland, entered in the National Court Register (KRS) under no. 0000994171, TAX ID (NIP): 9571149160 (hereinafter: the "Controller" or the "Organizer").Contact regarding personal data: infiniteforcepl@gmail.com.

## 2. Scope of Personal Data Processed

Depending on how you use the website and participate in the Festival, the Controller may process the following categories of data: identification data: first and last name, and possibly a stage name/nickname (if provided), date of birth (if required for age verification), contact data: email address, phone number (if provided), registration and Festival participation data: selected package/offer, information related to payments (e.g., payment status, date, amount, currency), instalment history (if applicable), technical data: IP address, device/browser identifiers, server logs, session data, image and recordings: image/likeness captured in photos and video materials recorded during the Festival (in accordance with the Festival Regulations), correspondence data: the content of messages sent to the Organizer.

## 3. Data Processed in Connection with Stripe Payments

If a participant chooses to pay via Stripe integrated with www.infinite-force.com, payment-related data is processed to the extent necessary to complete the payment and handle settlement. Depending on the payment method (e.g., card, digital wallet), Stripe may process, among others: the cardholder's / payer's name, email address, payment details (amount, currency, date, status, transaction identifiers), verification and security data related to the transaction (e.g., authentication results, anti-fraud mechanisms), partial payment instrument



data (e.g., card type, last digits), IP address and technical data related to processing the payment. The Controller does not receive or store full card data (such as the full card number or CVC), insofar as such data is processed directly by Stripe.

#### 4. Purposes and Legal Bases for Processing

Personal data is processed for the following purposes:

- 4.1. Registration and performance of Festival participation (Ticket / wristband / voucher), payment handling, settlement legal basis: Article 6(1)(b) GDPR (performance of a contract / taking steps at the data subject's request prior to entering into a contract) and Article 6(1)(c) GDPR (legal obligations, e.g., accounting and tax obligations where applicable).
- 4.2. Contact and handling inquiries (email, forms, correspondence) legal basis: Article 6(1)(f) GDPR (the Controller's legitimate interest in communication and handling organizational matters).
- 4.3. Festival organization, safety, operational order, handling notifications and complaints legal basis: Article 6(1)(f) GDPR (the Controller's legitimate interest in ensuring smooth organization, safety, and prevention of abuse), and where necessary also Article 6(1)(c) GDPR.
- 4.4. Establishing, pursuing, or defending claims legal basis: Article 6(1)(f) GDPR (the Controller's legitimate interest).
- 4.5. Publishing photo/video materials from the Festival for promotional, advertising, and publication purposes related to the Festival legal basis: Article 6(1)(a) GDPR (consent) and the Festival Regulations provisions regarding image/likeness; additionally, where permitted by law, Article 6(1)(f) GDPR (legitimate promotional interest) may apply.

## 5. Recipients of Data (Who May Receive Your Data)

Data may be disclosed only to the extent necessary to achieve the purposes described in this Policy, in particular to: IT and hosting service providers supporting the Controller, payment service providers (including Stripe), entities supporting the organization of the Festival (e.g., technical support, accreditation, media team, cooperating entities performing organizational tasks), authorities or entities entitled under applicable law, where the Controller is legally



obliged to disclose data.

#### 6. Transfers Outside the EEA

Due to the use of certain technological providers (including payment, analytics, or communication services), personal data may be transferred outside the European Economic Area, where the provider applies legally required transfer mechanisms (e.g., standard contractual clauses). Data is transferred only to the extent necessary and with appropriate safeguards.

#### 7. Data Retention

The Controller stores personal data no longer than necessary. In particular: data related to Festival participation and settlements: for the time needed to perform the contract and thereafter for the period required by law or until claims become time-barred, contact data and correspondence: for the duration of the correspondence and then as long as necessary to secure potential claims, data processed for promotional purposes (image/likeness): in accordance with the Festival Regulations and the granted consent, to the extent and for the time necessary for promotional and archival purposes.

#### 8. Your Rights

You have the right to: access your data, rectify your data, erase your data (where legally applicable), restrict processing, data portability, object to processing (where processing is based on Article 6(1)(f) GDPR), withdraw consent at any time (where processing is based on consent), without affecting the lawfulness of processing prior to withdrawal, lodge a complaint with the President of the Personal Data Protection Office (UODO). #### 9. Voluntary Provision of Data

Providing personal data is voluntary; however: failure to provide the data required for registration and Ticket purchase will prevent participation in the Festival, failure to provide data necessary for payment processing will prevent payment completion, failure to provide contact data may prevent the Organizer from responding to an inquiry.



# 10. Automated Decision-Making and Profiling

Personal data is not used for automated decision-making, including profiling, within the meaning of Article 22 GDPR.

## 11. Data Security

The Controller applies appropriate technical and organizational measures to protect personal data against unauthorized access, loss, destruction, or unauthorized disclosure, in accordance with generally accepted security standards.

## 12. Cookies and Similar Technologies

The website may use cookies and similar technologies to ensure proper operation of the website, provide security, and compile statistics and improve functionality. You can manage cookies through your browser settings.

## 13. Changes to This Privacy Policy

The Controller may update this Privacy Policy, in particular in the event of organizational, technological, or legal changes. The current version is published on www.infinite-force.com.
