Attorneys and Licensed Paralegal Practitioners

Volunteer to be an Attorney Mentor

Ongoing | 1-2 hours per month

Once certified, all Community Justice Advocates are assigned an Attorney Mentor whom they can contact with legal and ethical questions. Attorney Mentors play a key role in ensuring Advocates are confident and able to navigate issues in their scope of service.

Advise on Certification Curriculum

Time-limited | Variable commitment

All Certification Training Courses are designed with extensive input from advocates, community organizations, and service-area experts. Legal professionals are invited to assist with periodic revisions, including creation of materials such as training videos, assignments, and handouts.

Deliver Continuing Legal Education

One time | 3-4 hours per CLE

Community Justice Advocates complete 8 hours of CLE annually. Two-hour CLE sessions are tailored to the program's scope of practice. Topics are chosen based on feedback from Advocates and generally include legal skill building, substantive legal information, ethical practice information, trauma-informed advocacy skills, and similar content. We want to continually expose Advocates to many perspectives and strategies.
