### Notes:

- 1.) One ' mill ' = \$1 per \$1,000 dollars of taxable valuation.
- 2.) Taxes are calculated on **Taxable Value (TV)**; ie, Mills x **TV** = Tax Due.
- 3.) **Taxable Value** will usually vary from the the State Equalized Value (**SEV**), which is approx. 50% of market value.
- 4.) Cannon Township collects 100% of Forest Hills Public Schools Tax in Winter Tax billing.
- 5.) Cannon Township collects a 1/2% Administration Fee.
- 6.) Special Assessments such as Delinquent Sewer, Lights, Drain and Weeds may be added to Winter Tax bill.
