From the Desk of the Supervisor

The Cannon Township Board has always focused on being open and transparent in the conduct of your business. When I became Supervisor in January of 2011, the Board allowed public comment in the beginning of every Board meeting, and every person was allowed three minutes to comment. As of my first meeting as Supervisor, we added public comment at the end of each meeting and removed the time limit. I have always felt that there should be no limit in Cannon Township on free speech, and if something was important enough for someone to take the time to come to a meeting, they should not be limited in the amount of time they have. We have said, however, that if a person has five

minutes of something to say, they should do it in five minutes, not six or ten.

We recently had over a hundred people at a Board meeting when we were considering a revision to the Special Land Use Ordinance for recreational areas in Cannon Township, like, but not limited to, Cannonsburg Ski Area. Everyone at the meeting had an opportunity to address the Board, and everyone, without exception, had something meaningful to say. That was a very important moment for our Township, because it proved that the changes I mentioned above work very, very well. Everyone was courteous and respectful, and the Board appreciated every word that was said. As a result of this exercise in representative democracy, the Board was able to glean very important information and pass our concerns on to the Planning Commission for analysis and input. The Planning Commission then appointed a subcommittee to analyze those concerns. Then a subcommittee of the Board met with representatives of the Planning Commission and came up with a very good ordinance, as well as an amended Outdoor Assembly ordinance. Best of all, we had input and advice from interested citizens in the subcommittee as well. In Cannon Township, we realize that the collective wisdom of her residents far outweighs that of her Board.

Taking things one step further, we recently changed the make-up of our sewer committee, to include a board member who actually pays a sewer bill, Deb Diepenhorst, as well as residents of the township who similarly are on sewer. The advice and counsel of those residents has already begun to benefit the Township. Part of being open and transparent is first admitting that as an elected person, you don't automatically know everything, and that's okay.

Recreation Update

The Recreation Committee made a decision to construct two projects in the Recreation Plan this year. One is a trail extension from where the existing trail ends in Townsend Park to the Village of Cannonsburg. The other is the development of a park on the Township Center property, south of the building. Plans of both of these projects can be found on the web.

The trail project should be a welcome pathway bringing trail users into the Village of Cannonsburg where they can stop to eat at one of the restaurants there or pick up a picnic snack at the deli. This extension also brings us that much closer to a future connection to the trails in Ada Township.

The park project has been in the discussion phase since before the 2002 Recreation Plan was created. Design shows a small picnic pavilion, a "tot lot" (play area for preschoolers), a large, grassy open area where people could throw a Frisbee, kick around a soccer ball, or have a family softball game. There would be some walking trails,

including one that would be handicapped accessible and a small parking area nearby. This park would be adjacent to the existing trail and would be a welcome oasis for trail users.

I am applying for three grants to help fund these projects. The total being requested is \$445,000. The trail project is estimated at approximately \$420,000. The grant request from Michigan Natural Resources Trust Fund for this project is \$300,000. Two grants are being sought for the park – a Land and Water Conservation Fund grant for \$100,000 and a Recreation Passport grant for \$45,000. All three of these grants are due on April 2nd, so March is keeping me very busy.

Budget

Cannon Township adopted the Fiscal Year 2012 – 2013 Budget at the March 26th meeting. This year's budget will continue the tradition that began two years ago of building our fund balance so that we have a reserve enough for a year's operating cost. The Board is committed to maintaining the fund balance for general fund at \$1.2 million. We are also working at building up the sewer fund to handle any major repairs that might be needed. A copy of the budget is available on our website.

As I'm writing this, we're into our second week of summer-like weather. That's strange for the middle of March. My prediction is that we'll see some winter-like weather before spring and summer come to stay. Enjoy it while you can!

Spring Watershed News

Bear Creek is a trout stream that runs approximately 17 miles through Cannon Township. The Bear Creek Watershed drains approximately 20,096 acres of land and is located primarily in Cannon Township. Bear Creek is also a subwatershed to the Grand River Watershed.

Many do not know that the health of a creek is indicative of the health of the entire watershed. Point source pollution and nonpoint source pollution (such as water runoff from agriculture and development) have a direct impact on both the watershed as a whole and the health of a creek. What happens miles away from a body of water will eventually affect the quality of that water. Adequate filtration of rain and runoff through wetlands is essential.

Cannon Township takes its watershed health very seriously. Recently, Cannon Township applied for (and received) the Start-Up grant and the Volunteer



Stream Monitoring grant from the Michigan Clean Water Corps (MiCorps) through the Department of Environmental Quality for a stream study of Bear Creek.

The concept of studying the insects that live in a creek is much the same as the concept of a canary in a coal mine. There are insects that

are tolerant of pollution, somewhat tolerant, and intolerant. Finding these insects (macroinvertebrates) and counting their numbers in a given sampling can help determine the health of a creek. The more bugs you have in the creek that are intolerant to pollution, the healthier your creek is. The more samplings you take, the more reliable your data is. We have only taken one sampling so far. We will need a wide range of data before we can draw any conclusions.

The MiCorps grants have funded the supplies and training for this stream study for two years. Cannon Township has committed to continuing this study indefinitely after that. This stream study

relies heavily on volunteers. Many volunteers have previous experience and education in this field. That is certainly not a requirement! Cannon Township would like to welcome anyone ages 8+ interested in helping collect and identify macroinvertebrates. All equipment necessary will be provided. Two samplings will be taken per year, spring and fall. The next sampling will be April 14, 2012 at 10:00 a.m. We will provide training.

Fertilizer is harmful to our lakes and streams in large quantities

By now, many of you probably know that storm water runoff goes straight into our storm water drains. You may also know that those drains are connected directly to our lakes and whatever goes in there is untreated. What runs off into our drains includes anything we put on our lawns. This includes fertilizer. While your initial reaction to fertilizer is that it is good for the earth, it is harmful to our lakes and streams in large quantities. Fertilizer containing phosphorus feeds algae and pond weeds in our lakes. These

algae then compete with fish for oxygen. Phosphorus actually promotes the weeds that we may be paying to eradicate in our lakes!

Cannon Township has adopted a fertilizer ordinance to control the phosphorus going into our lakes. This ordinance states that no phosphorus-containing fertilizer can be applied within the drainage districts of our lakes. If you are a lawn care company, if you employ a lawn care company, or if you fertilize your own lawn, please be sure this ordinance is being followed. Any companies that apply fertilizer within the drainage districts must also be permitted by Cannon Township.
