From the Desk of the Supervisor - Steve Grimm

We were recently advised that Cannon Township was awarded a Storm Water, Asset Management and Wastewater (SAW) grant from the state, in the amount of \$476, 991.00. This money will be utilized to televise manholes, to conduct smoke testing in key areas to identify inflow and infiltration, to inventory and build sewer plans, making sure that the sanitary sewer system is accurately depicted on the Township's GIS system. The money will also be used to create a sanitary sewer flow capacity model that will identify any sewer capacity issues in the system and to update the Capital Improvement Plan. We will also use the money to determine the forty to fifty year cycle needs of the sanitary sewer system and estimate future sewer costs. We will also conduct a financial analysis of the sewer user chart system that will analyze future costs and revenue forty to fifty years out, enabling our engineers to advise us as to likely future sewer charges and borrowing options. At the end of all of this, the results of this assessment will be put into a Sewer Assessment Management Plan.

We have already used some of the money to complete the televising of the system, which enabled the sewer committee to recommend a near-term improvement plan to the areas most in need. Those areas are the north end of Silver Lake, the Silver Lake Lift Station

improvements and the Belding Road trunk. The Silver Lake improvements will be performed and completed in 2015-16 and the Belding Road trunk will be completed in 2018, and will be done in conjunction with MDOT improvements to Belding Road, saving sewer users thousands of dollars in costs. These projects will total approximately \$4,000,000.00 and will be paid for by obtaining low interest bonds.

Because we committed ourselves to strict conservative fiscal principles in 2011, when I became Supervisor and put Dick Davies, Deb Diepenhorst and Henry Betten on the new Sewer Committee, along with Gene Kuehle, Mark Verwys and Nick Van Belkum, we have added over \$250,000.00 to our general sewer fund, without unexpected and unpredictable increases in rates. By adhering to a 3% per year increase to keep up with the average cost of living, we have increased not only our fund balance, but our maintenance as well. Since we turned over operation and maintenance to the North Kent Sewer Authority, we have realized not only an improvement in service, but we have saved tens of thousands of dollars in the process. Because we have implemented a fiscally conservative approach, we will be able to pay for future repairs on a cash basis, while still maintaining a healthy fund balance to meet any emergency.

November Ballot Proposal

Kent County Dedicated Veterans Millage

There will be a proposed dedicated veteran's millage on the election ballot this November 4. The millage is dedicated and can be used only for veteran's services in Kent County. The proposed millage is limited to a specific period (eight years) and will cost a property owner \$2.50 for each \$100,000 of market value (.05 mills).

The supporting ballot committee (Citizens Supporting Kent County Veterans) reports the millage will be used to meet emergency service needs, provide better transportation to medical appointments and to improve outreach and assistance to veterans applying for benefits from the Veterans Administration.

Back To School...

Every year school bus accidents happen because many drivers forget about some school bus safety basics. Here are a few rules to follow when driving near buses:

- Michigan law requires drivers to stop at least 20 feet from a school bus with flashing red lights. The red lights indicate that children are either loading or unloading from the bus.
- It's against the law to pass a school bus with flashing red lights in every one of the country's 50 states.
- Be alert and patient around school buses and bus stops. Do not pass

school buses in school zones, for safety's sake.

- Pay attention to those people acting as crossing guards, and to the signs and instructions they use to keep children safe.
- Allow extra time for the drive from home to school.

Gearing up for November 4th

The Primary Election is over and we're gearing up for the November 4th General. By the time you're reading this, absentee ballots have already been sent. If you don't get yours by October 3rd and you think you requested one, please call Nancy at 874-6966.

Cannon Township's turnout for the Primary was 29.92%, much higher than the State (<18%) or County (19.21%) average.

Precinct 3 voters took the lead at 32.76%. These statistics include the absentee voters. The State has us preparing for a high turnout in November. Hope to see all your names on the voter lists!

If you anticipate being away from the community on Election Day, make sure to get an Absentee Ballot. Anyone 60 years of age or older or a voter with a handicap has the right to get one, too. It's a long ballot with four proposals-three for Cannon's voters in Lowell and Forest Hills districts.

FUTURE OF BELDING ROAD

Listed below is a quick summary of our upcoming projects on Belding Road as described by Pam Blazo of MDOT.

- Ramsdell to the Kent/Ionia County Line: Work is scheduled for 2015 from May to August.
- The hill cutting at Ramsdell is included in the project. It will be a combination of raising the intersection of Ramsdell approximately 2 feet and cutting the hill just west of the intersection by approximately 3 feet. During this work at Ramsdell, west bound Belding Road traffic will be detoured (east bound traffic will be maintained); we are expecting the work requiring the detour to be completed in 4 weeks. The remainder of the work to the East of Ramsdell will be done part-width with alternating two-way traffic maintained using flag control during the day.

- Wolverine to Blakely: Currently scheduled for 2017.
- Blakely to Myers Lake: A third turn lane will be added for 2017.

Recreation Update

If you've been by the Township Center lately, you saw a lot of construction going on behind the building. The Township Center Park is being built! When completed in early October, the park will contain a non-motorized loop around a wetland at the rear of the property, a small picnic shelter, an open playing field, parking area and a playground geared to preschoolers. This \$356,000 project will be partially funded (\$100,000) by the Land and Water Conservation Fund.

The Township decided not to construct the Cannonsburg Trail Extension until next year due to the bids coming in 33% over budget. We are hoping that the bid climate will change if this is presented as an early spring project.

The Bostwick Lake Trail Easement on the north side of Bostwick Lake is complete except for two signs and tree plantings. If you use this easement, please remember the rules that apply to all non-motorized trails in the Township.

- Non-motorized vehicles only
- Please remain on the trail
- Pets must be on a leash
- No littering

By the way, golf carts are motorized vehicles! We've already had complaints of their use on this trail. If identified, the drivers will be ticketed. And please, in addition to keeping your dog on a leash, remember to pick up after it if it relieves itself on your walk around the lake. There's nothing worse than stepping in doggy do! Plastic grocery bags serve this purpose well.

Thank you to everyone for supporting the recreation millage. It's amazing how expensive trail and park construction is. We'll be updating our Recreation Plan over the fall and winter months and would love your input on future projects. Watch our website and future issues of the Communicator for more information.

Bear Creek

Bear Creek is a 17-mile cold-water trout stream that flows into the Grand River. It has a watershed of approximately 30 square miles. That means that all of the water that falls within those 30 square miles can eventually make it into the creek. Some rain will soak directly into the ground and make it into an underground aquifer. As the water soaks in, it is filtered and cooled before it makes it into the stream. If the water falls on impervious (water can't soak in) surfaces such as roofs, roads, driveways, and parking lots, it can flow directly into storm drains and directly into the creek without being filtered and cooled.

Obviously, pollution flowing with the water is bad for the creek. This pollution can be in the form of oil, detergent, fertilizer, pesticides, animal waste, and even sand and dirt. Dirt/sand that does not belong in the creek covers the natural streambed gravel that trout use to feed and lay their eggs. It can also make the water murky. Did you know that warm water is also a pollutant? Trout populations do not thrive in warmer water temperatures. That is why it is so important to minimize the amount of warm water flowing directly into the creek and protect the creek with shade trees. Many property owners cut down trees around the creek to improve their view. They also mow grass right to the edge of the creek thinking that looks better. Bear Creek

needs lots of shade and lots of native plants at least 25 feet on either side of the creek (this is required in our Zoning Ordinance 15.04C). These plants filter water before it reaches the creek. Plants and trees help hold the soil in place so it does not wash into the creek. It also offers habitat for smaller animals.

If we are good caretakers of Bear Creek, there should be lots of macroinvertebrates (bugs) in the creek for trout to feed on. A healthy bug population is the perfect indicator of stream quality. To learn more, join our Stream Study! We sample macroinvertebrates in Bear Creek every spring and fall. Our next sampling is October 4, 2014.



Have you ever wondered what becomes of all the "stuff" that you drop off when Cannon Township hosts a free electronics recycling event?

Kyle Shoemaker, Vice President of Service at Comprenew, spoke with me when I worked with him to coordinate the recent event. Kyle said that Comprenew is a nonprofit corporation dedicated to inspiring environmental care and increasing vocation preparedness through education for all people and segments of society, regardless of religion, ethnicity, or status, through best practice technology recycling services.

It is Comprenew's mission to protect people and the environment from problems associated with electronics by extending the economic lifecycle of used electronics. They act as a resource for the community to recycle and educate, while providing job readiness programs.

Comprenew is an award winning, nonprofit corporation dedicated to inspire the local community to live and work in a sustainable manner by recycling electronics. They own and operate three refurbished electronic retail stores and partners with 17 recycling donation drop off sites around West Michigan. They are also the most certified recycling organization in the State of Michigan.

Kyle told me that all computers' hard drives are wiped clean. Some are recycled for parts, but others are refurbished and reused.

The grand opening is scheduled for Saturday, **October 4, from 10 am to 6 pm**. The Comprenew store will serve as a refurbished electronics retail store, electronics repair center, and donations site for obsolete and old electronic equipment.

Kyle said "Comprenew encourages all Cannon Township residents to utilize our electronics recycling. We are open Monday through Saturday from 10 am – 6 pm daily at the new Northland location. Stop by on October 4th and register to **win a \$200 gift certificate** to use at any Comprenew location."
