## From the Desk of the Supervisor - Steve Grimm

### *Mike Warmbier Appointed to Trustee Position*

**A**t its meeting on Monday, February 24, the Cannon Township Board appointed Mike Warmbier to the trustee position which became vacant when Diane Jones was appointed to the County Commission. Mike brings a tremendous amount of experience to the Board. He has been on the Planning Commission for the last six years, a year and a half as chairman (he's also an MSU Certified Citizen Planner), member of the Zoning Board of Appeals the past ten years, on the Township's IT Committee for the last two years, and he regularly attends Board meetings. Mike takes his dedication to Cannon very seriously, missing only one meeting in his ten year tenure serving the Township. He will remain on the Planning Commission as the Board representative. We know Mike will do a great job representing the residents of Cannon.

**P**rior to selecting Mike, we had invited all residents to submit applications for the position. A committee reviewed eight applications; of those three candidates were interviewed. David Phillips, of Lake Bella Vista, was one of the applicants. Even though he did not have prior involvement in township government, he was

considered for the board vacancy. We felt that he would better serve the Township on the Planning Commission, and he graciously accepted that appointment. Henry Betten, who has long been involved in the Township and was also seriously considered for the opening on the Board, agreed to serve on the Zoning Board of Appeals. We also appointed Terry Brod, who has spent many years on the Township's Board of Review, to sit on the Planning Commission.

**A**lso on the agenda for the meeting on the 24th was the renewal of the Special Land Use at the Cannonsburg Ski Area. This renewal had been voted down by the Planning Commission, but the Board, by a 4-2 vote (McBrien and Nelson dissenting) renewed the Special Land Use, with an amendment limiting amplified music to no more than four hours during any event or concert. Had the Board failed to approve the Special Land Use, the Grand Rapids Symphony's Picnic Pops would have been canceled. We also voted to implement a better communications system that would allow residents to lodge complaints at the Township if too much noise emanates from the concerts or events.

# Cannon Township

**The Cannon Township Recreation Committee has been very busy this past year. We have four major projects going on...**

**1 Bostwick Lake Park** – The committee made a decision to renovate the park. With support from the Township Board, a consultant prepared a plan that will add many improvements. I recently submitted a grant application asking for \$45,000 to help pay for this project that is estimated at \$98,000. The project will involve parking lot improvements, a sidewalk, deck, new stairway with landings, new retaining walls, and shoreline stabilization improvements. The entire park will comply with ADA requirements with the upper level being universally accessible. Since we are waiting on a grant announcement that won't happen until November, this project is scheduled for 2015.

**2 Cannonsburg Trail** – Last fall we received a grant award from MDOT through the Grand Valley Metro Council, thanks to Chad Sosnowski who submitted the application. This award is for \$245,700 and will be used to fund the trail extension from Townsend Park into the Village of Cannonsburg (total project cost is \$485,000). This project should be done in 2014.

**3 Cannon Township Center Park** – In 2012, Cannon was awarded \$100,000 from the Land and Water Conservation Fund for improvements on the Township property. Construction will commence this summer on the park that will include a pavilion, playground,

playing field, parking area and accessible trail that will extend to the southern property line and through a wetland area. The total cost for this project is estimated at \$317,000.

**4 Bostwick Lake Trail** – Cannon Township is in the process of obtaining an easement that will preserve access to residents who walk around Bostwick Lake. This easement will be defined and improved with crushed stone.

*These four projects will all use some of the millage money that you all so generously pay for recreation. A millage renewal will be on the ballot in August.*

We on the department, feel strongly that this ordinance will also help reduce the amount of nuisance calls and allow the Township to recover the expense of providing fire suppression efforts to

those individuals and businesses that do not adhere to the same rules as the rest of our residents.

## Budget Information...

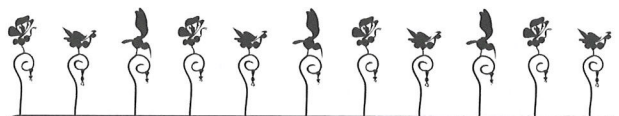
During the month of March the Budget Committee has been busy preparing the Township Budget for the fiscal year beginning April 1, 2014.

**S**everal major items have been included in this year's budget that were not included in prior years. **These are:**

- **\$75,000** for parking lot on 10 Mile Road for Luton Park (The total project will be approximately \$300,000 with Courtland Township contributing \$75,000 and the balance paid by the County.)
- **\$25,000** to increase shoulder width from 4ft to 6ft when 10 Mile Road is resurfaced this summer from Courtland Drive near Rockford Village to Myers Lake Avenue. (Courtland Township is also contributing \$25,000.)

**O**ther items include **\$28,000** to spread limestone on Bush Drive, **\$70,000** additional repairs on roads because of the cold and snow this winter, **\$29,000** for Master Plan update, **\$370,000** for a new fire vehicle, **\$239,300** for additional trail construction (\$485,000 total offset by \$245,700 grant), **\$217,000** for Township Center Park construction (\$317,000 total offset by \$100,000 grant), **\$66,700** engineering fees for trail and park, **\$10,000** for cemetery improvements (\$14,700 total offset by \$4,700 prior C.D.), and **\$10,365** for landscape improvements at the Township Center.

### 2014 Election News – AV Ballots

**B**efore every election we send out applications for Absentee Ballots to everyone on our permanent list. In order to qualify to be on the list, you must be 60 years of age or older, physically unable to attend the polls without assistance of another or you cannot attend due to the tenets of your religion. If your job generally requires you to be away from the community during the time the polls are open, we will also add you to this list. Please contact **Nancy (nancyp@cannontwp.org)** if you would like to be added to this list.

**E**ven if you are on the list and receive an application for an absentee ballot, you always have the opportunity to come to the polls to vote if you would like. If you don't send the application back, you won't get a ballot. If you do get a ballot, you can still vote in the polls if you "surrender" your ballot when you come in to vote. Just bring the ballot in, enclosed in its envelope, and ask to speak to the Chair when you arrive at your precinct.

**P**ersonally, I love the opportunity to vote an absentee ballot. As I make decisions on the races, I can vote those races, and then do more research on the ones I'm unsure of. I can have my laptop handy to Google candidates' names and read

about their positions on various issues. I'm excited about turning 60 this year and being qualified to vote this way.

**F**or years the legislature has debated the issue of "no reason absentee voting." I have always questioned why they are so reluctant to pass legislation to allow this, as it is a good option for our citizens, especially in elections with long, two-sided ballots. I'd love to see this opportunity available before my term ends in 2016.

**J**ust a note – forwarding requests at the Post Office do not apply to ballots. If you will not be collecting mail at your residence, please contact Nancy with the address where you would like your ballot sent. Even better – complete the area on the application form that gives an alternate address to mail your ballot.

**R**emember – election law allows you to return the sealed envelope containing a voted ballot from a person in your household. However, we are not allowed to give an unvoted absentee ballot to anyone other than the voter.

## Wish To Lodge A Complaint?

**It's** the middle of the night. Your neighbor's dog has been barking for two hours straight. You want to lodge a complaint, but you're worried that in your rush to get to work in the morning, you'll forget to call. What can you do?

Cannon Township has just developed a new **Phone Complaint System** that you can call 24/7. So pick up your phone and dial 874-6966 and wait for a response. This is what you'll hear after the general announcement: "If this is an ordinance enforcement issue, please press 1 to leave a message."

When you **press 1**, you will hear: "Please leave your name, number, specific information, and address of your concern. Press the # key after the message to reach the person on call, or hang up."

The morning of the next business day your message will be routed to the person responsible for enforcement of the issue. In the case of the barking dog, the Zoning Administrator will send a letter to the owner of the dog, registering the complaint and asking him to keep the dog quiet. If the dog is still barking after a week or so, please call again. The owner will get a second letter. Up to this point, the name of the person who complained is not included in the letters.

If a third letter is necessary, this is accompanied with a citation for a court appearance ticket. In order to issue this citation, witnesses to the violation must sign a statement.

*The barking dog example was given, but there are many other ordinance violations that could be handled with a message on this complaint line.*

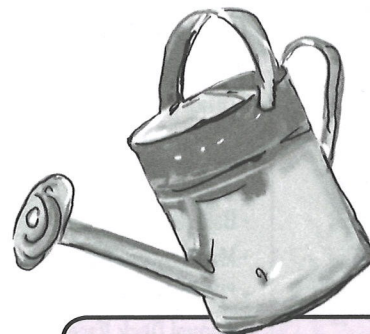

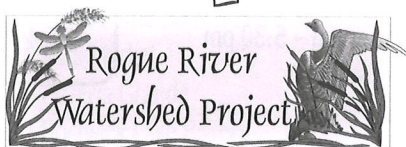

# Cannon Township Boat Docking Ordinance

*Spring is on the way, or so we hope! It has to come eventually, and with it, boating season.*

**Some key things to remember when putting in your dock:**

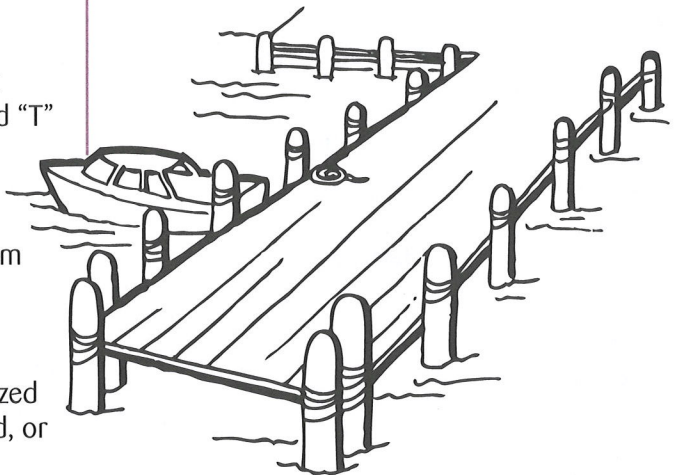
**1.** No more than one dock and one shore station/boat cradle shall be permitted per parcel. You may have one additional dock if you have additional frontage of 70 feet or more.

**2.** The length of the dock should not present a hazard to navigation, and "T" or "L" sections may not exceed 6 feet in width. Docks and boats must be at least 7 feet from side lot lines. Shore stations or boat cradles must be at least 2 feet from side lot lines.

**3.** No more than two (2) motorized watercraft and two (2) non-motorized watercraft may be launched from, docked, or utilized from each frontage.

**4.** No boat dock or lift shall be sold, leased, or the use thereof given in exchange for consideration to any third party, other than the owner or lessee of the lot and building thereon.

***Please know the intent of this ordinance is to protect the health, safety, and welfare of persons using these lakes. For those of you that live on the lake please review the "Boat Launching and Docking" ordinance found in our General Ordinances at [www.cannontwp.org](http://www.cannontwp.org). The General Ordinance is enforceable by Police power.***

**Important!** Residents will have to pay for mattresses/box springs (\$15) and whole tires (\$10)

### Rules:

- No liquids (paint, oil, etc.)  
Latex is okay if it's hardened.
- No brush or yard waste
- All tires must be cut in half or cut the sidewalls out

- No shovel-offs (smaller items should be bagged.)
- Propane and fuel tanks must be cut in half and cleaned out.
- Fencing must be folded or rolled up.
- Barrels must have one end open or be full of holes.
- No hazardous materials
