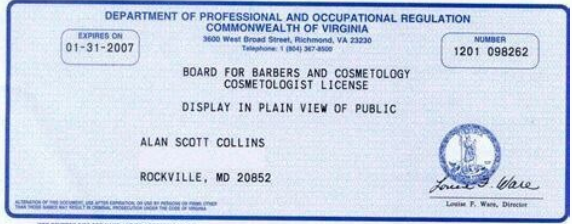

Then, complete, sign, and mail the examination application to the Arizona State Board of Cosmetology, including required documents such as a passport photo, certification of graduation, proof of lawful presence, high school education, age verification, and the initial fee of \$70. For student instructors, additional requirements include proof of current license and work experience form. Once the board receives a complete examination packet, the application process can proceed.

To apply for examinations, register online with Professional Credential Services, Inc. (PCS) and pay \$177 by credit card. Then, complete, sign, and mail the examination application to the Arizona State Board of Cosmetology, including required documents such as a passport photo, certification of graduation, proof of lawful presence, high school education, age verification, and the initial fee of \$70. For student instructors, additional requirements include proof of current license and work experience form. Once the board receives a complete examination packet, the application process can proceed. If qualified, we'll notify PCS, who'll then inform you via email about your practical exam date and provide instructions for scheduling your written test. If you don't qualify or need more information, the Board will notify you by mail only. For any questions, please call Suzi or Mimi at 480-784-4539. To renew your Arizona Cosmetology license, you can either use their online system or download and fill out the renewal document, then mail it in. It's recommended to renew at least 60 days prior to the deadline to avoid late fees. You can also renew in person or over the phone by contacting Licensing at 480-784-4539. To transfer a license from another state to Arizona, you'll need to submit an application, provide satisfactory evidence of your licensure or graduation, and pay the required fees. For aesthetics, cosmetology, nail technology, or instructor licenses by reciprocity, you'll also need to submit the applicable fees and certain documents to the Board. Important reminders: it's your responsibility to ensure you've applied with PCS and the AZ Board for exams. If you don't complete either application, you won't be scheduled for tests. Additionally, individuals must register with PCS under their full legal name as it appears on government records. Upon submitting a photo ID card, individuals must ensure that all names match. Upon approval from the Board, ATT letters will be sent within 2 business days for theory examinations and Admission Notices for practical examinations within 2-5 business days.

Practical Examination dates are non-negotiable, with an optional rescheduling fee of \$50 to change the date.  
In cases where individuals do not receive emails within 5 business days of approval, they should contact PCS to avoid missing an examination. Always check junk/spam mail folders for important updates. Name or email changes must be submitted via email (azcos@pcshq.com) and cannot be made over the phone. To qualify for an Instructor's license in Arizona, a person must: 1. Submit an application form prescribed by the Board 2. Hold a high school diploma or its equivalent as specified by the Board's rules, or provide satisfactory evidence of being at least 23 years old 3. Be a licensed cosmetologist, aesthetician, or nail technician with either: a. At least one year of practice, passed the school examination, and received 650 hours (cosmetology), 500 hours (aesthetics), or 350 hours (nail technology) for a cosmetologist, aesthetics, or nail technician instructor, respectively. b. Five years of licensed industry experience within the past ten years preceding the application, meeting requirements as specified by the Board's rules 4. Pass the examination for an Instructor license 5. Pay the prescribed fees
