TERMS BETWEEN CINCINNATI NATURE CENTER AND DONOR(S)

- Each engraved tile measures 12 inches by 12 inches. Inscriptions are permanent and cannot be changed once completed.
- This contribution provides recognition for the life of the tile but does not convey ownership or control of the tile or its placement.
- A stone mason engraves tiles on site twice annually. Once a gift is received, engraving will be scheduled for the next available visit, and donors will be notified upon completion.
- Cincinnati Nature Center will replace tiles that are damaged or destroyed due to natural causes.
- As the arboretum is a dynamic outdoor environment, Cincinnati Nature Center reserves the right to modify or discontinue this tribute opportunity at any time.
- To preserve the natural setting, Reflection Walls may not be decorated or adorned with flags, flowers, or other memorial items.
