General Fair Rules

These rules apply to all Exhibitors of the Fair. The Fair Board reserves the right to interpret rules and make final decisions regarding fair operations, exhibits, and eligibility when necessary. Please read carefully!

- The Franklin County Fair Board and Fair Management assume no responsibility for injury, loss, or damage to persons, livestock, exhibits, or personal property while participating in or attending the fair. Every reasonable precaution will be taken to protect exhibits and provide a safe and enjoyable fair experience.
- Exhibitors are responsible for the care, supervision, and protection of their own exhibits and animals throughout the fair.
- All animals must be properly groomed and prepared for exhibition.
- Exhibitors are responsible for certifying that their animals are free from infectious, contagious, or communicable diseases and have not been exposed to such diseases within thirty (30) days prior to the fair.
- Cattle and horses must be properly halter broken and manageable for safe exhibition.
- Milking dairy cows may be removed from the fairgrounds following the dairy show on Friday afternoon. All other exhibits and livestock must remain on the fairgrounds until official release time on Sunday unless otherwise approved by the superintendent or Fair Board.
- Exhibitors who fail to follow official checkout procedures may forfeit premium money and awards.
- Any person under the influence of alcohol or illegal drugs will not be permitted to exhibit, show, compete, or participate in fair events or activities.
- It is the responsibility of each exhibitor to:
 - Contact the appropriate superintendent
 - Ensure exhibits are properly entered and classified
 - Know judging times and schedules
 - Have exhibits or animals ready at the proper time
- Premiums will not be paid on unregistered male breeding animals. Registration papers must be presented to the superintendent upon request.
- 4-H and FFA livestock exhibitors wishing to participate in Open Class must submit a separate Open Class entry.
- Crop exhibits entered in 4-H or FFA must have a separate exhibit to be entered in Open Class competition..
- All entries must be on the fairgrounds according to the official Fair Book schedule and department deadlines.
- Only exhibitors with livestock projects are permitted to stay overnight on the fairgrounds.
- Youth staying overnight on the fairgrounds must be under the supervision of a parent, guardian, approved leader, or advisor at all times.

4-H/FFA Market Animal Rules

General Eligibility

- To be eligible to sell an animal at the Franklin County Market Animal Sale, members of Franklin County 4-H clubs and FFA chapters must reside in Franklin County for at least six (6) months prior to the fair.
- Market animals must be housed in Franklin County following the beginning weigh-in.
- Members may show and sell market animals through the calendar year in which they turn nineteen (19).
- Each member may sell only one market animal at the Franklin County Fair, whether beef, swine, lamb, market goat, or bucket calf.
- Each 4-H member is required to complete their project to sell their animal.
- Persons with disabilities who require alternative means for communication of program information or reasonable accommodations need to contact Laura L. Sant at the Franklin Extension or call (208) 852-1097.
- “The University of Idaho does not discriminate in education or employment on the basis of human differences, as required by state and federal laws.”

Animal Health & Drug Policy

- The use of drugs or substances not approved and labeled by the FDA is strictly prohibited.
- The use of tranquilizers, sedatives, or depressants is not allowed.
- All market animals may be subject to testing for substances prohibited by FDA, FSIS, USDA, and/or EPA standards.
- Any violation of drug policies will result in forfeiture of premiums, awards, and auction proceeds, and may result in disqualification from future Franklin County Fair 4-H/FFA livestock participation.
- The use of approved medications, including antibiotics, must be recorded in the exhibitor's record book.
- Exhibitors are responsible for observing all withdrawal periods prior to sale day.
- Grand and Reserve Champion market beef, lamb, swine, and goat may be tested immediately following their market classes.
- Care of all livestock animals must be consistent with accepted production practices and industry standards.

Show & Sale Requirements

- **NEW Show Order: (Quality first then Showmanship Class)**
- Members must participate in both Showmanship and Quality classes to be eligible for the Market Animal Sale.
- Members are expected to be present for the livestock sale.
- If a member cannot attend the sale, an alternate may show the animal in the sale ring. A 10% penalty of the sale price will be deducted from the exhibitor's check. Penalty funds will support the Franklin County 4-H/FFA Livestock Program.

Show & Sale Requirements Cont...

- Dismissal of an animal from the show or sale is at the discretion of the species superintendent.
- In the event an animal dies, the member should contact the Extension Office for project completion requirements.
- Members whose animals do not make weight are encouraged to participate in fitting and showing and complete a record book in order to complete their project and remain eligible for boost money.

Required Market Animal Show Dress Code

- Exhibitors must wear:
 - A plain white button-up shirt with collar and 4-H patch on the left shoulder, or an official FFA jacket
 - Nice jeans or slacks
- Shorts and tank tops are not permitted during shows or sale.
- 4-H patches may be purchased through the Extension Office.

Recommended Market Animal Sale Day Attire

- Participants may wear a button-up collared shirt of their choice.
- Neat, clean dark jeans (no holes)
- Boots or closed-toe shoes
- Belt where appropriate
- Clean and presentable appearance

Record Books

- Members required to enter livestock entries in Fair Entry
- 4-H exhibitors are required to complete and submit online record books.
- Record books must be completed, except for final sale information, by Monday, August 4.
- No sale money will be released until record books have been submitted and approved.

Champion & Sale Rules

- Grand and Reserve Champions are required to sell and will sell first in their respective species.
- If a member wins Grand or Reserve Champion in more than one species, the member must select which animal will sell.
- Additional champion animals may be recognized during the sale but may not be sold.
- Members must declare which animal they intend to sell within two (2) hours following the final quality class of the day.

Ownership & Identification

- All animals must be ear-tagged at entry weigh-in.
- Each member must identify which animal belongs to them at weigh-in.

Leader Responsibilities

- Assist with club and fair activities
- Ensure record books are completed and submitted
- Verify stalls and pens are cleaned
- Ensure thank-you notes are completed and turned in to the Extension Office with postage

Stall, Pen & Animal Care

- Pens for other market animals will be assigned by club or chapter.
- Clubs and chapters are encouraged to decorate their assigned areas.
- Exhibitors must provide their own feed and bedding.
- Animals must be clean, groomed, and properly cared for at all times.
- Exhibitors and parents are responsible for cleaning stalls and surrounding areas and for caring for animals until released from the fairgrounds.
- Livestock must have adequate food and water available at all times.
- Violation of stall and care rules may result in a \$30 fine per occurrence, deducted from livestock checks.

Stall Cleanup

- Stall cleanup must be completed between Sunday at 8:00 a.m. and Monday at 6:00 p.m.
- No one will be allowed into livestock areas for cleanup until animals have been removed from the grounds or approval is given by the superintendent.
- Failure to clean stalls and pens will result in fines withheld from livestock checks.

Entry Weigh-In

- Annual 4-H enrollment fees must be paid before entry weigh-in.
- A \$10 fee per animal will be charged at beginning weigh-in.
- Club and member enrollments must be completed no later than July 1.
- 4-H members must complete a minimum of six (6) hours of club instruction.
- One spare animal per exhibitor may be weighed in. Spare animals may only be used by immediate family members.

Final Weigh-in

- Final weigh-in will take place Tuesday of fair week.
- Beef, swine, goats, and bucket calves must be clean.
- One immediate re-weigh will be allowed before returning to pens.
- The Market Animal Committee reserves the right to limit the number of animals in the sale.
- White ribbon animals are not eligible to sell.

Sale Information

- Floor prices will be established by the Market Animal Committee according to buyer bids.
- A 4% sale fee will be deducted from the animal sale/bid price. Funds will be used to support the 4H/FFA market animal program. (boosts not included)
- Checks may be picked up on or after October 17th. Checks will be voided after 90 days.
- Livestock checks not cashed within ninety (90) days of issue will be voided.

Liability

- All entries are accepted with the understanding that neither the Fair Board nor the Livestock Committee shall be responsible for loss, theft, injury, or damage to exhibits, livestock, or personal property.

4-H/FFA General Rules & Info

A list of project requirements is available through the Extension Office.

General Instructions

- Youth must be enrolled in a Franklin County 4-H project during the current year to be eligible for county awards and participation.
- Each project and contest has its own rules and requirements. Members should refer to the 4-H project information and contest guidelines for complete details.
- Please follow all entry and checkout schedules listed in the Fair Book.
- Late entries cannot be accepted due to judging schedules. However, late projects may be entered in Junior Open Class if eligible.
- 4-H members must turn 9 years old during the current calendar year to participate in regular 4-H divisions.
- The same project may not be entered in both 4-H and FFA competition
- Cloverbud members ages 5–8 may enter projects for display only. Cloverbud entries are not eligible for premium money.
- Members participating in traditional projects must:
 - Follow the project member manual
 - Complete all required project work
 - Submit the required online *record book or record sheet

Record Books & Record Sheets

- *A completed online record book (when required) or record sheet must accompany all exhibits.
- Exhibits missing required paperwork may not be eligible for judging or premiums.

Project Pickup

- All 4-H projects, exhibits, and ribbons may be picked up at the Event Center on the Monday following the fair from 9:00–11:00 a.m. or 4:00–6:00 p.m. After those times, items may be picked up at the Extension Office.
- Any project that is not picked up or checked in for the Eastern Idaho State Fair will be discarded after October 31st. If special arrangements are needed, contact the Extension office prior to the fair.

Premiums

All 4-H club exhibits will be judged and will be awarded ribbons as classified:



Blue: \$3.00



Red: \$2.00



White: \$1.00

Only blue-ribbon projects are eligible for the Eastern Idaho State Fair.

County Fair Premiums will be available at checkout or at the Extension Office after fair. Any county premiums not claimed by September 30th will be forfeited. Any state premiums not claimed by October 31st will be forfeited.

Best Animal Record Book and Record Sheet Story

Cash and other prizes are available for the best Animal Record Book by species and best Record Sheet story by age division.

The Demonstration Contest

Will be held on Wednesday, August 5th.

All 4-H members who completed a 4-H project this year are eligible to participate. Contact the Extension office for contest guidelines and to register.

Eligibility

Youth exhibitors must be currently enrolled in Franklin County 4-H or a local FFA chapter (Preston or West Side Chapters) and follow all county and state requirements.

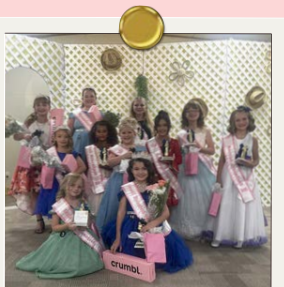

- Beef exhibitors, including bucket calf exhibitors, must provide a brand inspection slip or bill of sale at both beginning and final weigh-ins.

- The Franklin County Livestock Committee will give a cash award to the 4-H club or FFA chapter in Bucket Calves who keeps their animal pens clean and decorated. The pens will be judged on cleanliness and originality in decorations. Awards will only be given if earned.

1st place—\$40.00 2nd place—\$30.00 3rd place—\$20.00

Additional Market Beef Requirements:

- Exhibitors must be currently enrolled in 4-H and turn 9 years old within the calendar year. Exhibitors cannot turn 13 in the current calendar year.
- Calves must be born after March 1st, 2026, and before April 12th, 2026.
- The 4-H'er must own the calf by April 12, 2026.
- One spare animal per individual. Beginning weight shall not be more than 175 lbs. Only one animal may be sold, whether it be beef, bucket calf, swine, meat goat or lamb.
- Brand inspection fees may be deducted from beef and bucket calf checks if required.
- For safety reasons, halter-breaking beef animals before weigh-in is strongly recommended.
- Beef exhibitors, including bucket calf exhibitors, must provide a brand inspection slip or bill of sale at both beginning and final weigh-ins.
- A bucket calf is any breed of steer and must be weaned from its mother and off milk by final weigh in.
- No bulls will be accepted at the final weigh-in.
- Exhibitor may show only one bucket calf during the Fair.
- This is considered a beef project; beef breed showmanship will be used.
- Wash order at washing rack:
 - Beef 1st
 - Bucket Calves 2nd

4-H Horse Divisions

General Rules

- No 4-H horse member may show unless they are enrolled in a 4-H horse project or FFA chapter in Franklin County.
- Class divisions for Franklin County will be:
- Junior: 8–10 years old (8 years old as of December 31, 2024)
- Intermediate: 11–13 years old as of January 1, 2025
- Senior: 14–18 years old as of January 1, 2025, or in the 12th grade
- An 8-year-old turning 9 during the current year is eligible to show.
- 4-H exhibitors and parents must demonstrate good sportsmanship. Politeness is mandatory. No exceptions.
- 4-H members may use more than one horse as long as a supplement form is completed for each additional horse the 4-H member is entering. No horse/pony may be shown by more than one exhibitor in any one class. No exhibitor may show more than one horse/pony in any one class.
- Only stallions born after January 1 of the current year may be shown.
- Multiple rings shall be used as needed. Classes may not be held in order, so exhibitors must be ready and on call for each class.
- Plain, long-sleeved western white shirt with a collar, blue jeans, and western boots with heels (slip on with hard soles) will be the only acceptable attire. A 4-H patch must be placed on the left shirt sleeve.
- All 4-H and FFA members participating in any 4-H equestrian activity must wear an ASTM-SEI approved equestrian helmet whenever mounted on an equine or in a horse-drawn vehicle. Leaders and parents are also encouraged to wear helmets.
- If a horse is a known kicker, it must wear a yellow ribbon on the tail head at all 4-H events.
- Use of behavior-modifying drugs is prohibited. Suspected violations may be investigated by the Show Committee and veterinarian. Horses may be tested, and exhibitors may be disqualified.
- Exhibitors wishing to exercise horses may ride only in the warm-up arena. Horses may not be ridden in parking areas, livestock shed areas, between the grandstands and indoor arena, or on pavement. Violators may be dismissed from competition.
- Good showmanship shall always prevail. Unnecessary roughness, abuse of horses, or dangerous animals may result in dismissal from further competition.
- 4-H projects will be judged on the Danish system. Ribbons will be awarded in all classes.
- Play Day entry fees not turned in by the deadline will be charged a \$5.00 late fee.
- Spurs are permissible but must be dull with free-moving rowels or bumper style.
- No tie-downs, side-pulls, quirts, or bats are allowed.
- Exhibitors must maintain control of their horse at all times. Unsafe or reckless riding may result in dismissal from competition

4-H Horse Show Rules Cont...

- No chains may be used over the horse's nose; chains may only be used under the chin in Halter Showmanship classes.
- No tie-downs, side-pulls, quirts, or bats are allowed.
- Horses in performance classes must use a standard western bit and either Romal or split reins.
- Leather curb straps and curb chains must be flat and at least 1/2 inch wide.
- Bridles with nosebands are prohibited.
- Snaffle bit/hackamore classes are limited to horses four years old or younger in their first through third year of training.
- Youth must be the primary trainer.
- Horses may not compete in other riding events except Working Ranch Horse.
- Horses must be ridden with two hands.
- Only approved snaffle bits or hackamores may be used.
- County Fair Horse Show entry forms and record books must be submitted to the Franklin County Extension Office by Monday, August 4th at 5:00 p.m. No late entries will be accepted.
- Payments will be made for one showmanship class and one performance class at the County Fair 4-H Horse Show.
- Eastern Idaho State Fair qualification rules:
- Showmanship is limited to one entry per age division from each county
- Contestants must be county blue ribbon winners
- Counties may send two entries per performance class, with additional entries based on participation numbers
- Western Reining and Western Horsemanship allow one entry per 10 contestants
- Exhibitors qualifying in both Western Reining and Western Horsemanship may enter only one
- Individuals participating in class 9 may also participate in class 5 and class 19 but no other performance class. Individuals may participate in only one bareback class.
