Medical Expenses

Applies if you travelled **40 km or more one-way** to obtain medically necessary treatment that was **not available** locally. Receipts and details are required.

- Medical and dental expenses paid (receipts required)
- Transportation costs (vehicle, airfare, bus, taxi)
- Meals and accommodation (if travel was 80 km or more one-way)
- Attendant travel costs (if medically required)
- Costs paid for surrogate mothers and fertility treatments

Private Health Plan Premiums (PHSP)

Applies if you paid the premiums personally or are self-employed. If your employer paid the premiums, do not claim them personally.

Disability Tax Credit (T2201)

May apply if you or a dependent has a severe and prolonged impairment that markedly restricts daily activities, or requires life-sustaining therapy, and a medical practitioner has certified (or can certify) the condition on Form T2201. Approval may be retroactive and can affect other credits and benefits.

Saskatchewan-Specific Credits, Programs & Reporting (Complete only if applicable)

Saskatchewan Home Renovation Tax Credit

Applies if you incurred eligible home renovation expenses for a principal residence in Saskatchewan during the year.

Saskatchewan Active Families Benefit

Applies if you paid eligible registration or membership fees for children's sports, arts, cultural, recreational, or fitness activities.

Saskatchewan Graduate Retention Program (GRP)

Applies if you completed post-secondary education and may be eligible for the Saskatchewan Graduate Retention Program or have unused amounts carried forward from prior years.
