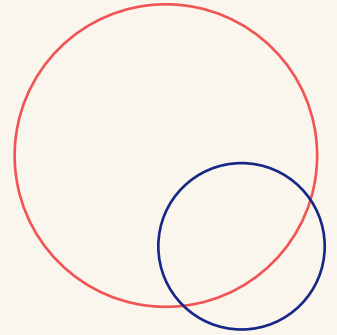




LEGAL DATA PROTECTION

Privacy Policy

How IroniC AB collects, uses, and protects personal data submitted through ironicbiotech.com.

This policy explains, in plain terms, what personal data Ironic Biotech collects when you visit or contact us through this website, why, and what rights you have over it.

1. Who we are

Ironic AB ("Ironic Biotech," "we," "us," or "our") is a biotechnology company registered in Sweden, with its registered address at Medicon Village · Building 401, 223 81 Lund, Sweden. We are the data controller responsible for the personal data described in this policy in connection with our website at ironicbiotech.com (the "Website").

2. Scope of this policy

This policy applies to visitors of the Website worldwide, including individuals in the European Union / European Economic Area, where the EU General Data Protection Regulation ("GDPR") applies, and individuals in the United States, where certain state privacy laws (such as the California Consumer Privacy Act, as amended) may apply. Section 8 sets out the rights specific to each region.

3. Personal data we collect

We keep the data we collect to a minimum. Currently, the only personal data we collect through the Website is what you choose to give us.

Contact form

When you fill out the "Contact Us" form, we collect:

- Your name
- Your email address
- Your phone number (optional)
- The subject / category of your enquiry (Partnership, Press, Consumer, or Other)
- The content of your message

We do not currently operate an online shop, newsletter sign-up, or job-application form on this Website, and we do not collect any payment information.

Automatically collected technical data

Our hosting and security providers (see Section 5) may automatically process limited technical information, such as IP address and browser type, as a normal part of operating and securing the Website. We do not use this information to build a profile of you.

4. Cookies and tracking technologies

We do not currently use cookies, pixels, or similar tracking or advertising technologies on this Website.

If this changes in the future, we will update this policy and, where required by law, ask for your consent before any such technology is activated.

5. Why we process your data, and who we share it with

We process the data you submit through the contact form to:

- Respond to your enquiry and correspond with you
- Assess and progress potential partnerships, press enquiries, or other business opportunities
- Keep a record of our communications with you

Legal basis (GDPR Art. 6(1)): we rely on our legitimate interest in responding to enquiries directed to us and developing potential business relationships (Art. 6(1)(f)), and, where an enquiry relates to a potential partnership, on the steps necessary prior to entering into a contract (Art. 6(1)(b)).

Who sees your data:

- Our team, who receive your message by email at info@ironicbiotech.com
- Webflow, Inc. — our website hosting and form-processing platform, which handles form submissions on our behalf (data processor)
- Cloudflare, Inc. — provides a bot-detection check (Cloudflare Turnstile) on our contact form to prevent spam (data processor)

We do not sell your personal data, and we do not share it with third parties for their own marketing purposes.

6. International data transfers

Some of our service providers, including Webflow and Cloudflare, are based in, or process data in, the United States. Where personal data is transferred outside the EU/EEA, we rely on the safeguards those providers have in place, such as the European Commission's Standard Contractual Clauses, to keep your data protected to a standard equivalent to the GDPR.

7. How long we keep your data

We keep contact-form submissions for up to one (1) year from the date of your last message to us, after which we delete or anonymize it — unless (a) a longer period is required to comply with a legal obligation, or (b) your enquiry develops into an active business relationship, in which case relevant data will be kept in line with that agreement and applicable law.

8. Your rights

If you are in the EU/EEA or UK (GDPR)

You have the right to:

- Access the personal data we hold about you
- Correct inaccurate data
- Request deletion of your data (“right to be forgotten”)
- Restrict or object to our processing of your data
- Receive your data in a portable format
- Withdraw consent at any time, where processing is based on consent
- Lodge a complaint with your local data protection authority — in Sweden, the Swedish Authority for Privacy Protection (Integritetsskyddsmyndigheten, IMY), imy.se

If you are in the United States

Depending on your state of residence, you may have similar rights, including the right to know what personal data we have collected about you, the right to request deletion of that data, and the right to opt out of the “sale” or “sharing” of personal data. We do not sell or share personal data with third parties for monetary or other valuable consideration.

To exercise any of these rights, contact us using the details in Section 12.

9. Data security

We take reasonable technical and organizational measures to protect the personal data you share with us against unauthorized access, loss, or misuse, including relying on the security features of our hosting and infrastructure providers.

10. Children's privacy

This Website is intended for business and professional audiences and is not directed at children. We do not knowingly collect personal data from anyone under the age of 16.

11. Changes to this policy

We may update this policy from time to time, for example to reflect changes to the Website or our data practices. The effective date on the cover page always shows the latest revision. We encourage you to review this page periodically.
