We are particularly keen to hear from accountants, financial managers, CFOs/CEOs and senior leaders with strong financial management and governance experience.

## About Arts Northern Rivers

Arts Northern Rivers is the regional arts development organisation (RADO) for the Northern Rivers. Established in 2003 by the region's seven Mayors and incorporated in 2004, ANR has grown to become the largest and leading RADO in NSW.

As the peak arts organisation for our region, we:

- Support and advocate for artists and creative industries
- Deliver services and projects that foster artistic innovation and excellence
- Work to ensure access to and engagement with arts and cultural activity across the Northern Rivers

We are an independent, not-for-profit organisation, supported by Create NSW and Northern Rivers local governments.

## The Opportunity – Treasurer (Board Director)

This is an opportunity to apply your financial expertise to a meaningful community role, supporting a dynamic arts organisation that has real impact across the Northern Rivers.

The Treasurer will work closely with the Chair, Executive Director and Board to provide:

- **Financial Oversight** – Monitor the organisation’s financial position and ensure transparency through quarterly and annual reporting.
- **Budget & Planning** – Oversee the annual budget, track performance, and advise on financial risks and opportunities.
- **Reporting & Compliance** – Present clear quarterly and annual financial reports to the Board; oversee audits and statutory reporting.
- **Risk Management** – Identify and monitor financial risks, ensure appropriate internal controls, and safeguard long-term sustainability.
- **Strategic Input** – Provide financial strategic leadership and contribute to organisational planning and decision-making.
- **Governance Participation** – Actively participate in Board and committee meetings and contribute constructively to discussions.

### TIME COMMITMENT

Approximately 4 hours per quarter, including Board meeting preparation, attendance, and occasional organisational events. Five Board meetings per year generally 90 minutes. Meetings held during the day at the ANR office in Lismore.

This is a voluntary (unpaid) governance role.

### SKILLS AND EXPERIENCE SOUGHT

We are particularly interested in candidates with:

- Professional accounting or finance qualifications (e.g. CPA, CA or equivalent), and
- Experience in financial management, budgeting, reporting and risk management, ideally at an organisational or business-unit level
- Experience with governance, audits and compliance (board or senior management level experience will be highly regarded)

Experience in the not-for-profit, arts, community or government-funded sectors is desirable but not essential.

We are looking for someone who:

- Has a genuine interest in supporting the arts and creative industries in the Northern Rivers
- Brings integrity, professionalism and sound judgement
- Is collaborative, practical and solution-focused
- Is committed to good governance, transparency and accountability
