HEMOCARE TEAM LEAD (EXTERNAL)

Stó:lō Service Agency (SSA) requires the services of a qualified **Home Care Team Lead** to fill a vacancy with the **Health Services Department**. *Pursuant to section 41 of the BC Human Rights Code, preference may be given to applicants of Aboriginal ancestry.* Please self-identify on your cover letter or resume.

The **Home Care Team Lead** supports the delivery of respectful and culturally grounded home care services for community members receiving care in their homes and community. This role provides leadership, supervision and day-to-day support to the Home Care team, ensuring services are coordinated, responsive, and aligned with the vision, mission, goals, and values of SSA. The Home Care Team Lead works collaboratively with nurses, health professionals, families, and community partners to ensure that Elders and community members receive care that supports dignity, independence, comfort, and connection to community. Practice within the program aligns with guidance from the First Nations Health Authority (FNHA), Fraser Health, and relevant professional standards where applicable. The Home Care Team Lead supports the philosophy of client and family centered care, recognizing the importance of relationships, culture, and community in health and healing.

This position reports to Associate Director of Health, and the successful candidate will work out of the Chilliwack office. Some travel may be required for this position.

QUALIFICATIONS/REQUIREMENTS:

- Diploma or degree in Nursing (RN, LPN, RPN), Social Services (SW), or related health discipline.
- Current registration, or eligibility for registration, and in good standing with the appropriate regulatory body (e.g., BCCNM, or equivalent).
- Minimum of five (5) years of experience in home care, community health, or related services.
- Minimum of one (1) year providing clinical supervision, mentorship, or leadership within an interdisciplinary team environment.
- Proficiency in using computers including Microsoft 365, Word, Excel, Outlook, EMR systems, and video conferencing platforms.
- Demonstrated commitment to advancing Truth and Reconciliation and delivering culturally safe services to Indigenous individuals, families, and communities.
- Demonstrated knowledge and understanding of Indigenous cultural practices, traditional wellness approaches, and the impacts of colonization and intergenerational trauma.
- Must maintain the confidentiality guidelines of all records, materials and communications concerning clients, staff and SSA.
- Completion of WHMIS, Transportation of Dangerous Goods, and Safe Food Handling Course.
- Current First Aid, CPR & AED certification.
- Formal training and experience in home care coordination, elder care, or palliative care, wound care, footcare, chronic disease management or other clinical training is an asset.

Successful candidates will be required to provide the following if screened in for an interview:

- Proof of education documentation.
- Professional references: Names and email addresses of two references.
- Must possess and maintain a valid Class 5 BC Drivers' License.
- Must successfully pass the required pre-employment RCMP Criminal records Check.

SALARY RANGE:

Starting at \$43.00 per hour (based on qualifications/experience).

TYPE OF POSITION:

Full-time with benefits, subject to 3-month probationary period and planned performance evaluations.
