





These general terms and conditions of sale (GTC) apply to any individual or legal entity wishing to purchase services (access to the relaxation area, facial or body treatments) offered by Spa des Tannins at Bellevigne Bourgoene (SH Chambolle - RCS Diion 948024930).

Bellevigne Bourgogne reserves the right to adapt or modify these general terms and conditions of sale at any time. The general terms and conditions of sale applicable to a booking are those published on the Website on the date the booking is made.

For any other method of booking, the Customer will receive the GTC in response to their booking request. Confirmation of the booking by the Customer implies their full and unreserved acceptance of these terms and conditions.

RESERVATION

To book a service, the Customer may use the following channels:

On the website https://www.bellevigne-hotels.com/

When making a booking, the Customer must provide certain mandatory information, including some personal data necessary for processing the booking. The booking procedure includes the following steps:

Step 1 - Select dates and number of participants / Step 2 - Select services / Step 3 - View price / Step 4 - Presentation of the booking summary and total price / Step 5 - Mandatory provision of contact details by the Customer, and provision of credit card details (card number, expiry date and security code) for the payment of the deposit. By ticking the box, the Customer confirms that they have read and accept the T&Cs and the privacy policy before finally confirming their booking; no booking is possible without this agreement. The Customer confirms and validates their booking and proceeds to payment. Entering bank details indicates the Customer's acceptance and has the effect of binding them contractually to Bellevigne Bourgogne. The Customer's bank details are encrypted and protected / Step 6 - The Customer receives an email confirming their booking. If the confirmation email is not received within 24 hours of the booking, it is the Customer's responsibility to contact Bellevigne Bourgogne to check the information provided and ensure that the booking has been taken into account.

Entering bank details constitutes acceptance by the Customer and has the effect of binding them contractually to Bellevigne Bourgogne. The Customer's bank details are encrypted and protected. The Customer receives their booking confirmation by email.

On site at the Spa reception

FOR GUESTS OF THE BELLEVIGNE BOURGOGNE HOTEL:

Free access to the relaxation area included. Includes access to the outdoor swimming pool (except during annual closure), sauna, steam room and sensory shower.

Opening hours:

Relaxation area: every day from 9am to 7pm, free access.

Treatment area: every day from 10am to 6pm, by appointment.

Please wear your swimsuit when visiting the spa. Bathrobes and slippers are available in your room.

FOR EXTERNAL CUSTOMERS:

Half-day access to the relaxation area is offered with any treatment booking of over 50 minutes. Includes access to the outdoor pool (except during annual closure), sauna, steam room and sensory shower.

Opening hours:

Relaxation area (without treatment): every day from 9am to 7pm, by reservation and subject to availability.

Treatment area: every day from 10am to 6pm, by reservation.

EXPERIENCE AT THE SPA DES TANNINS:

Arrival at the Spa

We recommend that you arrive at the Spa reception at least 10 minutes before the start of your treatment or relaxation session so that you have time to get changed. If you arrive late, the duration of your treatment will be reduced so as not to impact the next customer, and the full price will be charged.

Spa des Tannins, a haven of peace:

As a space dedicated to well-being and relaxation, calm, silence and tranquillity must be respected. To ensure a truly relaxing experience, we ask that you preserve the peaceful atmosphere of our establishment. Intimate relations are prohibited. Any activity involving complete nudity is also prohibited. Please note that smoking is prohibited within the Spa. In order to preserve the harmony of the Spa, we also ask that you kindly switch off your mobile phone. We reserve the right to refuse entry or expel, without refund, any Customer whose attire is inappropriate or whose behaviour is incorrect or contrary to hygiene and good manners.

Treatments:

Our massages are non-medical and non-therapeutic wellness and relaxation treatments. The time spent settling into the treatment room, resting, undressing and dressing, and leaving the treatment room is not included in the massage duration, provided you arrive 10 minutes before your treatment. The treatment times specified correspond to the actual treatment times: for example, for a 20-minute, 50-minute or 1 hour 20-minute treatment, please allow 30 minutes, 60 minutes and 1 hour 30 minutes respectively. Furthermore, access to the treatment rooms is strictly reserved for guests. We provide disposable underwear for use during treatments in the treatment rooms.

Children:

Children under the age of 16 are only allowed access to the outdoor swimming pool, where children under the age of 12 must be supervised by their parents. Children over the age of 16 may access the relaxation area when accompanied by an adult.

Access to treatments is reserved for adults.

OUR TERMS AND CONDITIONS

LINEN .

For external customers, changing rooms equipped with bathrobes and slippers are available. Laundry baskets are provided in the changing rooms: please place your wet towels in these baskets. Towels are provided free of charge, but must be returned to the spa reception or placed in the basket provided for this purpose at the exit. Any items not returned will be charged at £27 for a bathrobe and £22 for a towel. Slippers are provided free of charge and must be worn at all times. Please note that towels are compulsory in the sauna.

HEALTH.

We kindly ask you to inform us of any specific medical contraindications when making your booking. For example, if you have high blood pressure, cardiovascular problems, allergies or are undergoing treatment. If you are pregnant, please inform our team, as some of our treatments may not be suitable for you. Our establishment reserves the right to refuse anyone whose state of health could present a risk.

LOSS:

The management accepts no responsibility for the loss or theft of your valuables. We advise you to keep them in the private lockers provided. Glasses and jewellery are not permitted in the sauna or steam room.

GIFT VOLICHERS :

Treat a loved one to a sensory experience, a journey for the senses in a unique setting. Gift cards are valid for one year from the date of issue. Upon expiry, the gift card loses its initial value. They are non-transferable, non-refundable and non-exchangeable. Current promotional offers cannot be combined.

PRODUCTS .

To enhance your experience, a boutique area is available at the spa reception. Here you will find the products used during your treatment as well as a wide selection of complementary items.

PRICE - PAYMENT - CANCELLATION:

The prices relating to the booking of services are communicated before and at the time of booking.

Prices are confirmed to the Customer inclusive of all taxes (VAT included), service included, in Bellevigne Bourgogne's commercial currency (the Euro). The prices communicated are only valid for a limited period.

A deposit of 50% of the total amount of the services selected by the Customer is due at the time of booking. The Customer may cancel their booking no later than 48 hours before the start date of the services. In this case, Bellevigne Bourgogne will refund the amount paid by the Customer. After the above-mentioned deadline, the booking becomes non-cancellable and non-refundable. The remaining 50% of the total amount of the services must be paid on site on the day of the booked appointment.

In the event of a no-show or cancellation of the booking after the above-mentioned cancellation deadline, no refund will be made and the payment made will be retained by Bellevigne Bourgogne.

PERSONAL DATA:

Under the terms of this agreement, it is agreed that Bellevigne Bourgogne is the data controller within the meaning of the applicable regulations, namely Regulation (EU) 2016/679 of 27 April 2016, known as the General Data Protection Regulation (GDPR), and Law No. 78-17 on Information Technology and Civil Liberties, as amended.

APPLICABLE LAW:

The GTC are governed by French law.

Bellevigne Bourgogne informs the Customer that, in the event of a dispute relating to these GTC, they may resort to conventional mediation or any other alternative dispute resolution method, under the conditions set out in Title I of Book VI of the Consumer Code.
