HERD NAME REGULATIONS

1. The herd's name is used as a prefix and no other breeder is permitted to use this name, except by permission of the registered owner and of the Society.
2. Names of large towns or well-known places are NOT acceptable, nor any name covering a large area to which several other breeders might have an equally good claim.
3. Herd names can only be made of one or two words. If two words are chosen, only one or more words can be added to the name of any calf, as calf's names cannot contain three words and a numeral.
4. A herd name cannot be registered until the registered fee is received.
5. It is advisable to submit alternative names when completing the *herd name form*, although the first choice will be registered whenever possible.
6. It is necessary for a member who wishes to commence breeding pedigree Hereford cattle to register a herd name. In the case of a member having both horned and polled herds – animals will not be distinguished by herd name but will be distinguished by initials following their entire name depending on what result the genotype returns. i.e. HH for horned, PP for Homozygous polled, or PH for heterozygous polled
