Public offer Agreement

1. Subject of the Agreement

- 1.1. The Service Provider offers professional event hosting, scenario writing, and concept development services.
- 1.2. The scope, format, and price of the services are individually agreed with the Client before payment.
- 1.3. The services are personally delivered by Oleksandr Barin, Director and authorized representative of Foreverodessa OÜ. If he becomes personally unavailable (e.g., due to illness or travel restrictions), the Service Provider may offer an alternative solution or issue a full refund.

2. Acceptance of the Offer

- 2.1. Submitting an order and/or making a payment means full acceptance of this Offer.
- 2.2. The Agreement is deemed concluded once payment is received.

3. Payment Terms

- 3.1. Prices are determined according to the agreed proposal.
- 3.2. Payment may be made via credit/debit card through **Wise** or other listed processors.

4. Rights and Obligations

- 4.1. The Service Provider undertakes to perform the services on time and with due quality.
- 4.2. The Client must provide all required information and pay on time.

5. Liability

- 5.1. The Service Provider is not liable for failure to perform due to reasons beyond its control.
- 5.2. If performance is impossible due to the Service Provider's fault, the Client receives a full refund.

- 6.1. All disputes are resolved amicably, and failing that — under the laws and jurisdiction of Estonia.
