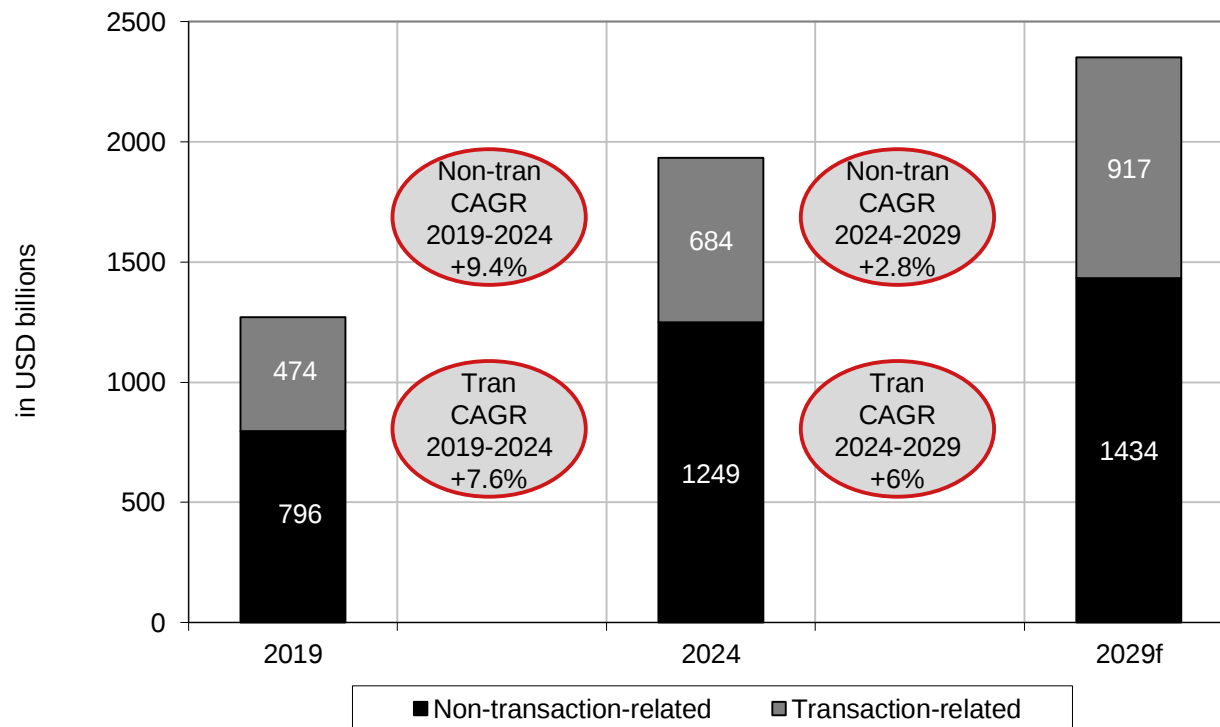

Payment Processing Is Expanding Into Integrated Commerce Infrastructure

- Capgemini, based on research, finds that merchants expect payment providers to deliver integrated capabilities that improve operational efficiency and customer experience rather than standalone payment acceptance. Likewise, the European Commission Joint Research Centre's study of the online payment ecosystem shows that growing payment complexity is increasing demand for platforms capable of connecting gateways, acquirers, wallets, and alternative payment methods through unified infrastructure.

Unified Platforms Are Becoming More Important in Merchant Payments

- Adyen highlights how its platform combines payment acceptance, acquiring, risk management, data analytics, and financial products within a unified architecture. Fiserv's 2025 Annual Report similarly describes the expansion of merchant solutions through the Clover ecosystem, integrating payment acceptance with software and business-management capabilities. These examples illustrate how individual payment providers are expanding their merchant offerings beyond transaction processing.

Merchant Software And Embedded Services Are Expanding Provider Value

- Fiserv's 2025 results show Merchant Solutions organic revenue growth of 6%, supported by the expansion of the Clover ecosystem, which integrates payment acceptance with point-of-sale software, analytics, loyalty, and business management. At the same time, research from Bain & Company indicates that embedding payments and financial services directly into software platforms is becoming a major source of merchant acquisition, retention, and new revenue opportunities.

Integrated Commerce Ecosystems Expand Competitive Differentiation

- Providers differentiate through combinations of payments, software, data, fraud prevention, and embedded financial services, according to McKinsey. Integrated merchant ecosystems are becoming an increasingly important source of competitive differentiation as providers combine payment acceptance with commerce, operational, and financial-service capabilities.
