Re: South Bow GP (Canada) Ltd. (South Bow), as general partner on behalf of South Bow

(Canada) Limited Partnership

South Bow GP (Canada) Ltd. CER Tariff No. 78 (2026 Abandonment Surcharge)

Pursuant to Section 229(1)(a) of the Canadian Energy Regulator Act, South Bow files the enclosed tariff, CER Tariff No. 78, to be effective January 1, 2026.

South Bow is filing CER Tariff No. 78 to update the Abandonment Surcharge for the Keystone System. The Annual Contribution Amount (ACA) was calculated pursuant to the Commission's May 24, 2025 Decisions and Direction regarding select companies' set-aside and collection mechanism filings<sup>1</sup>, and the Commission's March 27, 2024 approval of TransCanada Keystone Pipeline's Abandonment Cost Estimate.<sup>2, 3</sup> The ACA was last updated on November 20, 2024; these changes are detailed in South Bow's response to CER Information Request No. 1.<sup>4</sup> Details of the calculation of the Abandonment Surcharge are available in Attachment 3 to CER Tariff No. 78.

South Bow will provide notice of this filing to shippers and interested parties, and post CER Tariff No. 78 on its external website.<sup>5</sup>

# Attachment 3 CER Tariff No. 78

**Abandonment Surcharge Calculation** 

Abandonment Surcharge calculations reflect the last approved Abandonment Cost Estimate. The adjusted Final South Bow ACA is comprised of the South Bow ACA of approximately \$13.2 Million and tax true-ups totaling approximately \$35.5 thousand to be retained by South Bow.

The South Bow 2026 Abandonment Surcharge is calculated by dividing the Final South Bow ACA by the Total Forecasted 2026 Volume. The calculations are shown in detail below.
