

Privacy policy

Protecting your private information is our priority. This Statement of Privacy applies to www.unlocktradercapital.com and **Unlock Trader Capital LLC** and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Top Tier Funding, LLC include www.unlocktradercapital.com and **Unlock Trader Capital LLC**. **Unlock Trader Capital LLC** website is an eCommerce site. By using **Unlock Trader Capital LLC** website, you consent to the data practices described in this Statement and all extensions and addendums to this Statement.

Collection of your Personal Information

In order to better provide you with products and services offered, The Alpha Trader may collect personally identifiable information, such as your:

- First and Last Name
- Home Address
- Mailing Address
- E-mail Address
- Phone Number
- Financial Information

If you purchase **Unlock Trader Capital LLC** products and services, we collect billing and credit card information. This information is used to complete the purchase transaction or issue payments to you. We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services.

These may include:

- (a) registering for an account;
- (b) entering a sweepstake or contest sponsored by us or one of our partners;
- (c) signing up for special offers from selected third parties;
- (d) sending us an email message;
- (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future for the same purpose.

Use of your Personal Information

Unlock Trader Capital LLC collects and uses your personal information to operate and deliver the services you have requested. **Unlock Trader Capital LLC** may also use your personally identifiable information to inform you of other products or services available from **Unlock Trader Capital LLC** and its affiliates.

Sharing Information with Third Parties

Unlock Trader Capital LLC may sell, rent, or lease customer information to third parties for the following reasons: We will collect this data and provide it to third parties if it is a necessary step in the User account creation process, contributes to the ease of use, reliability, or functionality of our products, or if it is of mutual interest to **Unlock Trader Capital LLC**. **Unlock Trader Capital LLC** may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. - (c) act under exigent circumstances to protect the personal safety of users of The Alpha Trader, or the public.

Opt-Out of Sale or Disclosure of Personal Information to Third Parties

In connection with any personal information, we may sell or disclose to a third party for a business purpose, you have the right to know:

- The categories of personal information about you that we sold and the categories of third parties to whom the personal information was sold; and
- The categories of personal information that we disclosed about you for business purposes.

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity or prosecute those responsible for that activity;
- Debug, identify, and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided by law;
- Comply with the California Electronic Communications Privacy Act;

Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent. Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us. Comply with an existing legal obligation or otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
