This Privacy Statement explains what personal information TLI ABM Inc (d/b/a Elevate Health Technologies) ("we", "us", "our") collects when you use our website, www.elevateht.com, (the "Site"), how we use, disclose and protect your personal information.

SECTION 1 – PERSONAL INFORMATION WE COLLECT

You may provide us personal information through the Site, such as when you log into your account, sign up for a demo, fill out webforms, or sign up for marketing emails. Personal information includes, but is not limited to, your name, employer or company, work email address, and professional phone number.

 acquiring entity will still have to comply with the commitments we have made in this Privacy
 Statement. This Privacy Statement will remain valid and in full force and effect in case of change
 of ownership of the Site, and subsequent transfer of your information to the new owner.
- To protect our rights and interests, and the rights and interests of other users of our services, such as use or disclosure of personal information if to fulfill a contract or if required to do so by law, court order, subpoena, for public policy reasons or to serve justice, or other legal process; as requested by a governmental or law enforcement authority.
