ADDENDUM 2

Attention: All interested bidders

RE: CLEANING AND GROUNDS ROUTINE MAINTENANCE

Pursuant to **Clause 8** of the Instructions to Bidders (ITB) regarding amendments to the Bidding Documents, the Authority hereby issues this **Addendum No. 2** for both the Cleaning Routine Maintenance (CRM) and Grounds Routine Maintenance (GRM) Programs currently advertised. Accordingly, this addendum shall form part of the original bidding documents.

With the issuance of this Addendum, it is the responsibility of the prospective bidders to ensure they have received and acknowledged it. The Authority is not liable of any risks, misunderstandings, or omissions arising from a bidder's failure to obtain or review this Addendum.

The amendments and modifications to the above-stated Routine Maintenance Programs are as follows;

Cleaning Routine Maintenance Program:

- 1. The addition of one Zone or Contract to the Cleaning Routine Maintenance Program. The added contract detail is;
 - Fagalii Airport Terminal Cleaning Routine Maintenance Zone 7; Contract Number: 07-SAA-CRM/25".

The tender document for the added Zone 7 will be available for uplifting from **Wednesday** 13th August 2025 at 10:00 am from the Authority Main Office.

- 2. Contractors are now allowed to uplift up to seven (7) tender documents (all seven zones) instead of three (3) as stipulated in the original tender document. However, the condition to award only one (1) contract per contractor remains unchanged.
- 3. The deadline for tender submission is now postponed to **Monday 15th September 2025 at 11:00 am**. The location for tender submission remains unchanged.

& Grounds Routine Maintenance Program:

- 1. The addition of two Zones or Contracts to the Grounds Routine Maintenance Program. It is important to note that this amendment was made to further divide Zone 7 and Zone 8 of the landside areas to four (4) smaller Zones. The additional contracts are;
 - Faleolo Airport Grounds Routine Maintenance Zone 9 (Landside); Contract Number: 09-SAA-GRM/25".
 - Faleolo Airport Grounds Routine Maintenance Zone 10 (Landside); Contract Number: 010-SAA-GRM/25".

The revised tender documents for Zones 7, 8, 9, and 10 will be available for collection from the Authority's Main Office starting **Wednesday**, **13 August 2025**, at **10:00** am. Contractors who have already collected the original documents for Zones 7 and 8 are not required to pay the SAT \$100 uplifting fee and may simply exchange them for the revised documents.

- 3. The deadline for tender submission is now postponed to **Monday 15th September 2025 at 11:00 am**. The location for tender submission remains unchanged.

All other conditions and requirements of this tender shall remain unchanged.
