## Biannual Personal Interests Returns Summary

## Lodgement Period: 1 September to 30 September 2025

*The Local Government Act 2020* (sections 133 and 134) requires that specified persons including Councillors, members of delegated committees and nominated officers must submit a record of their personal interests to Council's Chief Executive Officer (CEO). A nominated officer is a member of council staff who (a) has a statutory delegated power, duty or function; and (b) is nominated by the CEO because of the nature of that power, duty or function.

The first Personal Interests Return is to be completed and submitted to the CEO within 30 days of a council employee being nominated or being appointed to a nominated position. A Biannual Personal Interests Return follows for the duration the position is held between:

- 1 March and 31 March; and
- 1 September and 30 September.

A Personal Interests Return is a record of interests that contain information of shareholdings, trusts, business associations or other private interests of the key people making decisions at councils. A summary of these interests must be made available to the public on Council's website. This assists in ensuring that decision-making is conducted in an impartial manner by key individuals in Council.

**Details of the below summarised items are required to be disclosed by specified persons on a Bi-annual Personal Interest Return since lodgement of their Initial or Bi-annual Personal Interest Return as per the *Local Government (Governance and Integrity) Regulations 2020*:**

<p><b>Regulation 9 (1) (e)</b></p> <p>Any paid employment (other than Council) since the specified person lodged the preceding initial or biannual personal interests return, if the income from the employment exceeded \$10,000.</p>	<p><b>Regulation 9 (1) (k)</b></p> <p>Any gift received by the specified person, the value of which equals or exceeds \$500, including gifts in the form of goods or services and multiple gifts that together equal or exceed that amount.</p>
<p><b>Regulation 9 (1) (f)</b></p> <p>Any person or body for whom the specified person currently is, or at any time since the specified person lodged the preceding initial or biannual personal interests return, has acted as, a consultant, contractor or agent and whose payments to the specified person exceeded \$10,000.</p>	<p><b>Regulation 9 (1) (l)</b></p> <p>Any other interest which the specified person has decided to disclose on the basis that it may give rise to a general conflict of interest or a material conflict of interest within the meaning of s 127 or 128 of the <i>Local Government Act 2020</i>.
