### 2025 Small Business Tax Deductions Cheat Sheet

# High-Impact Deductions Most Owners Miss



- 1. Home Office Deduction Up to \$1,500 (Simplified) or % of actual costs
- Self-Employment Tax Deduction Deduct 50% of SE tax (Schedule)
- 3. Qualified Business Income (QBI) Up to 20% of net income
- 4. Section 179 & Bonus Depreciation Up to \$1.25M Section 179 & 40% bonus in 2025
- 5. Augusta Rule Rent home to a business for up to 14 days, taxfree income
- 6. Hire Your Kids Shift income, avoid FICA/FUTA under 18

#### Deductions by Business Type

- 21. Health Insurance (Self-Employed) Deduct 100% on Schedule 1
- 22. Long-Term Care Insurance Deduct up to IRS limits based on age
- 23. Retirement Contributions SEP IRA, SIMPLE IRA, Solo 401(k)
- Education (Skill-Based) Classes, books, licenses for current work
- S-Corp: Accountable Reimbursements Home office, mileage, utilities
- 26. S-Corp: Payroll Taxes Employer share deductible
- 27. S-Corp: Fringe Benefits Structured via W-2 only
- 28. C-Corp: Pension Plans Cash Balance or Defined Benefit plans
- 29. C-Corp: Charitable Donations Up to 10% of taxable income
- 30. C-Corp: Tax Credits WOTC, R&D, Health Insurance Credit

### **Essential Deductions for All Businesses**

- 7. Business Rent Office, co-working, and equipment lease costs
- 8. Utilities Electricity, water, internet (prorated if home office)
- 9. Phone & Internet Deduct % used for business
- 10. Business Insurance Liability, property, workers' comp, etc.
- 11. Office Supplies Stationery, postage, small tools
- 12. Business Meals 50% deductible, 100% for company events
- 13. Business Travel Airfare, hotel, rental cars, meals
- 14. Vehicle Use 70¢ per mile (2025) or actual expenses
- Repairs & Maintenance Fully deductible if not capital improvements
- 16. Bank & Processing Fees Credit card, bank, merchant fees
- 17. Professional Services Legal, accounting, tax advisors
- 18. Startup Costs Up to \$5,000 in startup + \$5,000 in setup
- 19. Advertising & Marketing All promo and branding expenses
- 20. Cost of Goods Sold (COGS) Inventory, materials, shipping

## Hidden or Underused Deductions

- 31. Apps Slack, Notion, ChatGPT, cloud storage
- 32. Health Savings Account (HSA) \$4,300 individual / \$8,550 family (2025)
- 33. Tax Prep Fees CPA, software, audit support for business filings
- 34. Business Loan Interest Deduct interest, not principal
- Create-a-Deduction Strategy Timing purchases, donor-advised funds
