

**SPALDING COUNTY BOARD OF ELECTIONS AND VOTER REGISTRATION

**The Regular Monthly meeting of the Spalding County Board of Elections and Voter Registration was held at the Office of Elections and Voter Registration at 825 Memorial Drive at 10:00 am, on Monday, July 21, 2025. In attendance: Vice Chairman James Newland presiding, Chris Piland and Dexter Wimbish (arrived at 10:15) Also present were Elections Director Kim Slaughter, Attorney Stephanie Windham, and Kelly Romero to record minutes.**

**Election Supervisor Report** –

**Voter Registration Update:** Presented by Sandra Hardy (Total number of Registered Voters as of July 21, 2025 – 54,497.)

**Tiles that have been processed:** (Voter Registration will resume July 22, 2025.)

- Vital Records – 44
- Felon Records – 8
- Mentally Incompetent – 1

NGE Mailing – July 10, 2025: This mailing will target records who have inactive status continuously for 2 federal general elections. These records (2,387) have been mailed a notice, put on a 40-day clock and will be moved to Canceled status if no response is received. Postage for NGE mailers = \$1,647.00

NO CONTACT Mailing – July 22, 2025: This mailing will target approximately 1353 voter records with Active status that have not had any activity in 5 calendar years. (2020, 2021, 2022, 2023, 2024.) If a voter on the NO CONTACT list does not respond within 40 days after the mailer is sent, they are moved to Inactive status.

### **Election Update**

#### **Elections Director Kim Slaughter reported the following about the July 15, 2025 PSC Special Primary Run-off:**

- Slow but successful election
- Due to a thunderstorm, a couple precincts had water leakage, but voting equipment was not affected. Management was notified
- Several precincts lost power for a short period of time, but all machines returned to their normal status with no change in number of usages.
- One precinct did have trouble with a poll pad and a voter filed a complaint. They were moved to another poll pad and continued the process. A new card encoder and cord were deployed to this location and everything worked well thereafter.
- If our county had qualified under 21.2.270, we would have saved around \$17,758 for the special run-off by having it held in one location.
  - Dexter Wimbish suggested the following to Attorney Stephanie Windham. He would like for counsel to draft/propose legislation for an exemption for counties that will set a base line to create a process where we can petition to say we only have this amount of people and it's going to cost us this amount of money. Director Slaughter advised this law applied only to Primary elections.

#### **Board Mandated Hand Count for the Special Primary Run-Off July 15, 2025**

- After all results were loaded into the election Management System, categories for the Board mandated audit were hand drawn and the results were as follows:
- PSC District 3
  - Advance in Person – Precinct 7
  - Absentee By Mail – Precinct 20
  - Election Day – Precinct 16

The Board mandated hand count balanced to that of the results loaded into the Election Management System on Election night.

**Interviews for Election Assistant** – Interviews begin today through Wednesday. A follow-up will be provided of any decision to the board. After this position is filled, Director Kim Slaughter will begin to fill the open part time position.

**Precinct Consolidation** – There will be a presentation given at the August meeting of consolidation recommendation and will be placed on the agenda for a vote.

**LJA Engineering** – Contacted Director Kim Slaughter at the direction of County Manager Steve Ledbetter to begin the estimated cost process for the renovation of the entire office space.

- GAVREO (GA Voter Registration & Election Officials) conference will be held in Savannah, Ga on August 10<sup>th</sup> -13<sup>th</sup>. Dexter Wimbish would like to attend virtually.
- The August meeting has been rescheduled due to the conference and will be held on August 5<sup>th</sup>, 2025, at 6:00 p.m. at our regular location, Courthouse Annex, 119 E Solomon St, Room 108
- Director Kim Slaughter will continue to train and learn the new finance software, Tyler Technology, which went live right around Election time.
