**The Regular Monthly meeting of the Spalding County Board of Elections and Voter Registration was held at the Spalding County Courthouse Annex at 119 E Solomon St. Room 108 Griffin, GA 30223 at 6:00 p.m. on Tuesday, August 5, 2025. **Election Supervisor Report** –

**Voter Registration Update:** Presented by Sandra Hardy (Total number of Registered Voters as of August 5, 2025 – 54,773.)

NGE Mailing – July 10, 2025: This mailing will target records who have inactive status continuously for 2 federal general elections. These records (2,387) have been mailed a notice, put on a 40-day clock and will be moved to Canceled status if no response is received. Postage for NGE mailers = \$1,647.00

NO CONTACT Mailing – July 22, 2025: This mailing will target approximately 1353 voter records with Active status that have not had any activity in 5 calendar years. (2020, 2021, 2022, 2023, 2024.) If a voter on the NO CONTACT list does not respond within 40 days after the mailer is sent, they are moved to Inactive status.

ELM Update: Our office has processed 568 NGE mailers as returned mail.

REIF Tickets (Reporting Elections-Systems Issues Form)-one Reif Ticket was submitted on July 22, 2025, concerning incorrect signatures on cards through the DDS tile. This issue has affected 27 voter application cards. The issue has not yet been resolved and has been noted on the calendar for review in 14 days.

### **Election Update**

#### **State Risk Limit Audit:**

- Audit selection: Absentee by Mail Batch 2 and Election Day Precinct 12
- Audit began Thursday, July 24, 2025 at 9:00 am and ended approximately at 9:20 am.
- All audit results balanced to that of the results loaded into the Election Management System on Election night.

**Contract for Polyglot Labs/Eyesore** – A meeting was held with Garrett Massey and Beth Davidson to review the new website in its entirety. Submissions were made for additional changes/updates. Polyglot will be emailing the test URL tomorrow (Tuesday) for the Elections Director's review and approval.

**Interviews for Election Assistant** – There are two front runners with a couple of more applications and the goal is to have this position filled after the return from Conference. After the Elections Assistant is filled, the Elections Director will begin working to fill the open part time position.

**Precinct Consolidation** – There will be a presentation given at the September meeting of consolidation recommendation and will be placed on the agenda for a vote. Ms. Slaughter stated that she has a meeting scheduled with GIS Consultant, Bryan Haynes, for a final review of various data in hopes to answer any questions from the Board.

**Remodeling of newly acquired space:** – The Task Order Form has been signed and submitted to our office by County Manager Dr. Steve Ledbetter and Assistant County Manager Erica Dye. Ms. Slaughter will be meeting with LJA the week of August 18<sup>th</sup> for a final review of the layout.
