Such government entity must have an official community service program and a designated supervisor with verifiable contact information. Examples of government agencies are as follows: Fire Stations or Police Departments, State Parks, County Community (please verify that they allow community service prior to performing hours.). All mandatory community service hours shall be completed by the defendant at a rate of not less than 6 hours per week, unless otherwise specified by the probation officer.
