Terms and Conditions:

- 1. Should a Learner be unable to attend any specific session, Smartschool Academy must be provided at least 24 hours' notice in advance. Failure to do so will result in no refund being given nor rescheduling of the session.
- 2. There is no guarantee that any specific session booked for a certain time slot can be rescheduled to another time slot.
- 3. Afternoon study classes will only be utilised for afternoon study and not for extra classes.
- 4. Learners must attend scheduled classes punctually. No additional time for study or instruction will be provided should a Learner arrive late.
- 5. Classes, in relation to any specific learner, booked for a certain time slot, cannot be rescheduled to another time slot.
- 6. Only 5 learners will be allowed per class, with the exception of revision classes, where no more than 10 learners will be allowed per class. This exception will however not apply to afternoon study.
- 7. Only 10 learners will be allowed per Saturday class, with the exception of revision classes, where no more than 20 learners will be allowed per class. This exception will however not apply to afternoon study.
- 8. At least one month's written notice must be provided should the parent/guardian desire to cancel this agreement before the end of the term. No monies paid in advance shall be refunded or prorated.
- 9. Monthly payment for the following month must be provided in advance and no later than the last day of the preceding month. Should the account for the Learner be paid by way of direct withdrawal, payments shall be taken out as directed by the pre-authorised debit agreement. Cash payment directly paid into the bank account will result in an additional deposit charge. Cash payments can be made directly at the office without any penalties.
- 10. Smartschool reserves the right to immediately cancel all classes for a specific learner, should any payment not be made to Smartschool punctually, on or before the due date thereof. All payments are strictly upfront. Smartschool reserves the right to allocate a financial penalty towards the child's invoice for not adhering to the aforementioned not exceeding R850.
