**STIPULATION OF SETTLEMENT WITH
LEAVE TO APPLY FOR CLERK DEFAULT
JUDGMENT PURSUANT TO [REDACTED]**

THIS SETTLEMENT AGREEMENT AND RELEASE (this "SETTLEMENT AGREEMENT") is entered into by and between **PAINTED PAWS LLC; ANYTHING FOR YOU; CREATIVE TOUCH SALON & SPA; CENTRAL BARK** ("Seller"), **ELEESA A COLLINS** [REDACTED] ("Guarantor(s).") and referred to herein together with Seller collectively and individually as (the "Sellers"), and [REDACTED] ("Purchaser,") and referred to herein collectively with the Sellers as (the "Parties") on this **March 10, 2026** (the "Effective Date").

WHEREAS, the Parties entered into a receivables purchase agreement on September 28, 2022; ("Purchase Agreement")

WHEREAS, Purchaser alleges Sellers are indebted to them in the amount of \$49,031.60 **plus attorneys' fees and costs for a total balance of \$58,837.92** ("Total Balance")

WHEREAS, Purchaser filed an action against Sellers in [REDACTED], Case No. [REDACTED] (the "Action")

WHEREAS, the Parties desire to fully and finally resolve the Dispute;

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED BETWEEN THE PARTIES AS FOLLOWS:

1. Sellers shall pay to Purchaser the agreed "**Settlement Amount**" of **\$39,000.00** as full and final satisfaction of the Purchase Agreement by wire or ACH to Purchaser's attorney as follows:
 - **\$39,000.00** to be received by Purchaser's attorney no later than close of business March 27th 2026 (5 p.m. EST)
