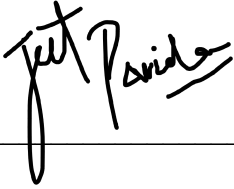
5. **APPOINTMENT OF AN EXTERNAL AUDITOR:**

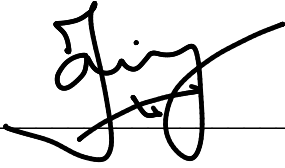
6. **CLOSE OF MEETING**
