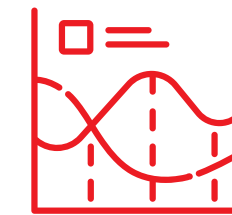

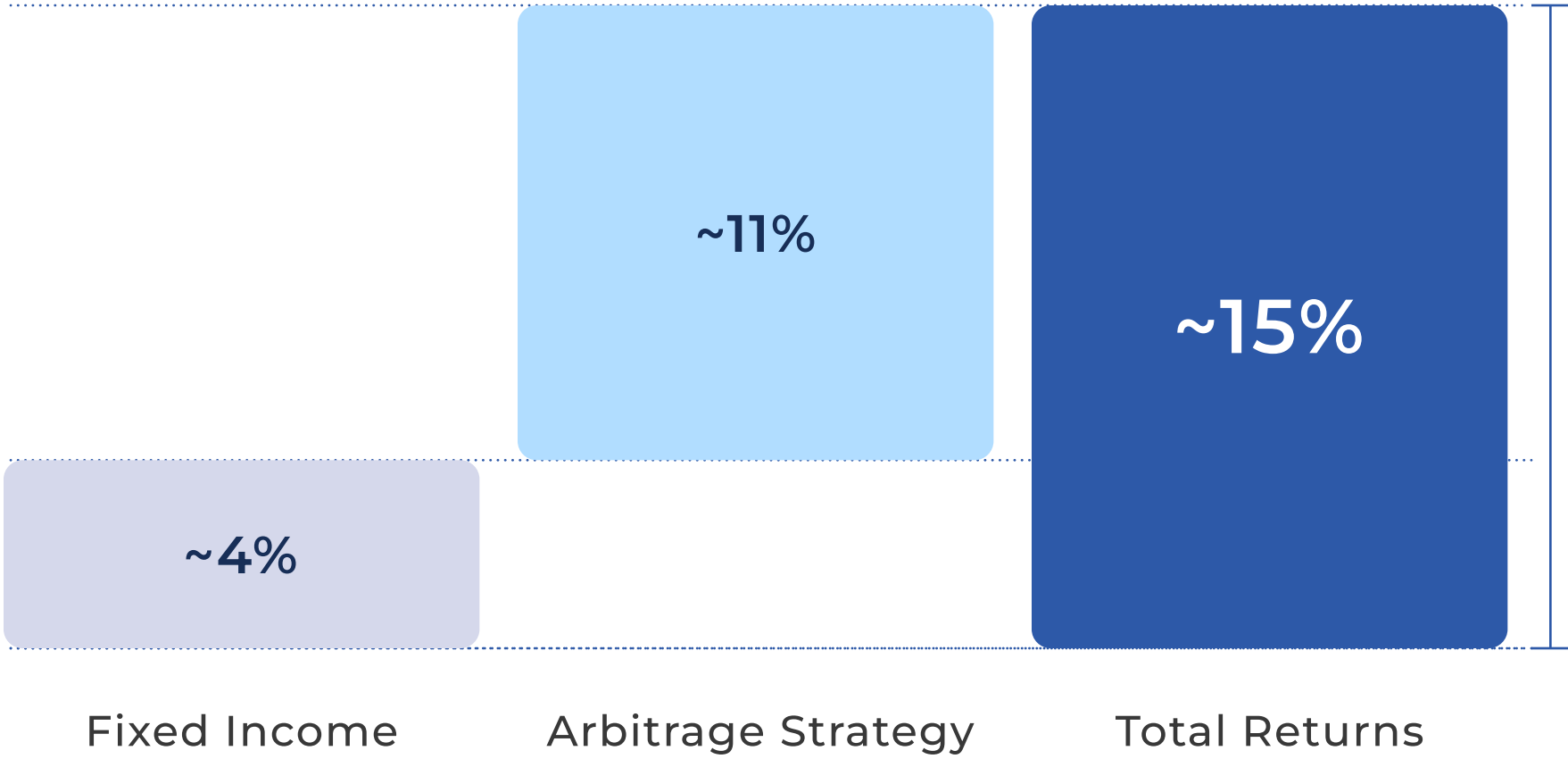

Risk Factors

The table above shows the trailing returns of IDP versus Asset weighted and Equal weighted benchmark indices of Nifty AIF Category III Index, Relevant Sub-Category Index, and Nifty TR indices over specified horizons. For instance, during the 1-year period (i.e., from September 30, 2023 to September 30, 2024), IDP achieved a CAGR of 9.75%, while the Nifty AIF Category III Asset Weighted Index, the Long Short Equity Asset Weighted Index, Nifty 50 TR Index and Nifty Composite Debt TR Index achieved CAGRs of 31.26%, 22.49%, 33.00% and 9.12% respectively.
