Project Description:

The landowner owns horses and currently utilizes the area of interest for pasture. The southern-most pasture has wetland pockets and is not an ideal location to pasture the horses. The landowner desires to plant trees in this pasture to create a forested buffer and wildlife habitat. There are small areas with native plants, but reed canary is growing throughout the field.

The stream is located on the western edge of the pasture and there is an existing forest canopy approximately 30 feet wide from the stream—woody invasive species are moderate to heavy in this area and along the stream bank and the contractor will treat the woody invasives *and reed canary grass* as part of this RFP. Tree planting will not be conducted in this area.

The contractor will plant trees and shrubs in the remainder of the project area with the exception of a very small existing tree island--the tree island will not require planting but will require woody invasive removal. The contractor will treat woody invasives *and reed canary grass* in the remainder of the area to be planted.

In addition to required herbicide application, invasive control may also require cutting and mulching in Zone 1 and in the tree island.

Post planting establishment services are NOT included in this RFP. The landowner will perform all maintenance activities.

The successful bidder will be responsible for the following:

Service 1: Site Preparation

- Invasive Control: Invasive control (woody invasive and noxious weeds and reed canary grass) will occur in late summer/fall of 2025 and will occur throughout the entire 1.84 acre project area (Zones 1 and 2) as depicted in Attachment A Forested Riparian Buffer Plan Map. The primary invasive plants to be controlled are reed canary grass, multiflora rose, bush honeysuckle and autumn olive. Appropriate herbicide will be applied to control the invasives.
 - The majority of the **woody** invasives are located in Zone 1 and in the existing tree island in Zone 2. While planting will not occur in Zone 1, woody invasive species **and reed canary grass** will be controlled here. Invasives are generally light in Zone 2 with the exception of reed canary grass. Control of reed canary grass is not to be included as part of the invasive control (except when done as part of the spot spray at tree planting locations as explained below). Herbicide is to be applied by the contractor to all reed canary grass throughout the entire project area. There are approximately 0.5 0.75 acres of reed canary grass to treat.
 - Cutting and mulching of woody invasives may be needed in addition to the required herbicide application. Contractor shall follow up with a spot treatment of herbicide to the cut stumps if cutting and mulching. It is permissible to treat the invasives with herbicide and allow the dead stems to stand so that they rot and decompose over time. This will reduce damage to the existing native vegetation. Chipping and mulching is also an acceptable method, however it may not be possible to get mulching equipment into the

site due to wet conditions. In addition, care must be taken to minimize damage to existing native vegetation.

- To the extent that is practical, contractor will minimize damaging or spraying existing native trees, shrubs and vegetation such as milkweed and iron weed.
- Spot Spray at Tree Planting Locations: Apply appropriate herbicide (post emergent/non-selective required and pre-emergent as appropriate) in minimum 6ft x 6ft square spots to the 180 areas to be planted with trees/shrubs. This will occur in late summer/early fall 2025 and ideally will be done at least 2 weeks prior to planting but may be applied within 1 week after planting.

Contractor shall complete and submit Attachment B - Spray Report or equivalent to Chesapeake Conservancy for each herbicide application.

Contractor shall follow all pesticide product labels, laws and regulations.

Service 2: Implementation

- Tree/Shrub Planting: Planting will occur in fall (October/November) of 2025 and will consist of
 planting 3-gallon containerized stock (2-gallon may be acceptable pending availability but 3 gallon
 is strongly preferred) on 1.2 acres. See the plan map in Attachment A for planting location.
 Trees/shrubs will be planted at a density of 150 stems/acre. A total of 180 trees and shrubs will be
 planted.
 - Contractor will apply deer repellent to all planted trees and shrubs at time of planting.
 - Trees and shrubs will be planted in the ecologically appropriate areas, with species tolerating wet conditions planted in wet areas, and species preferring dry sites planted in drier areas.
 - To allow for the landowner to mow between trees, the spacing between trees shall be a minimum of 10 feet. The spacing between shrubs shall also be a minimum of 10 feet except in areas where shrub clumps may be planted. Trees and shrubs may be planted in dense clumps less than 10 feet apart in the areas of heavy reed canary grass while leaving the areas of heavy Ironweed unplanted.
 - Shelters are <u>not</u> to be used or installed.
 - The following species are required to be planted in the listed quantities and locations. If species, sizes or quantities are not available, contractor will contact the project manager and Chesapeake Conservancy to discuss substitutions.

- Contractor shall complete Attachment C Final Report or equivalent. Final Report will include the following:
 - a. List of all tree and shrub species and quantities planted.
 - b. Provide a minimum of 5 high quality project photographs with descriptions. Photographs of work in progress as well as "before and after" are encouraged. Photographs shall be emailed to the Conservancy at frohrer@chesapeakeconservancy.org.

Contractor will ensure that their work complies with all local, state and federal laws and regulations.

The contract will include, but is not limited to, the materials, labor and equipment to complete the activities listed in the Project Description.

RFP TERMS AND CONDITIONS

Selected contractors will be working with Chesapeake Conservancy and Chesapeake Bay Foundation on the implementation of this project.

TIMELINE:

Contractors shall include with their response the proposed dates for the following:

- Start date of site preparation
- Start date of implementation
- Completion date of implementation

Site preparation and implementation is anticipated to start in September – October 2025.

All services must be completed by November 15, 2025.

If the contracted services are not completed within the designated time period (as specified in the resulting contract from this RFP), the contract can be extended if agreed to in writing by Chesapeake Conservancy and the contractor.

<u>WARRANTY/PLANTING GUARANTEE:</u> Bidders shall include with their response, a description of their planting guarantee/warranty.

PENNSYLVANIA ONE CALL:

Contractor shall follow all laws and regulations relating to the Pennsylvania One-Call System, including submitting all required locate requests to the Pennsylvania One-Call System to assist with the prevention of accidental damage to underground public utilities. If designing the project, the contractor shall also submit all required design notifications to the Pennsylvania One-Call System.

COMMUNICATION:

Communication between the contractor, Chesapeake Conservancy and Chesapeake Bay Foundation is crucial to a successful project. The contractor shall notify Frank Rohrer, Chesapeake Conservancy (570-372-4065) and Ashley Spotts, Chesapeake Bay Foundation (215-498-7333) at least three (3) days prior to beginning site preparation/implementation and prior to final departure from the site.

PAYMENT INFORMATION:

Contractor shall invoice the Conservancy for services rendered during the preceding month. Invoices will be paid after all required documentation has been received and approved AND the Conservancy receives reimbursement from its funding source. We anticipate the time from invoice submission to payment to be 60 days. This may be longer if our payment from our funder is delayed. Required documents may include an invoice, Application for Payment form, enhanced minimum wage documentation, final report and spray report.

GRANTS:

The terms and conditions of the Pennsylvania Department of Conservation and Natural Resources Forest Buffer Grant (BRC-RFB-28.6-81) apply to the contracts that result from the RFP. Copies of the grant are available upon request.

WORKER PROTECTION INVESTMENT AND CERTIFICATION FORM:

Commonwealth grants require contractors to sign the Commonwealth of Pennsylvania Worker Protection Investment and Certification Form acknowledging compliance with Executive Order 2021-06, Worker Protection and Investment (October 21, 2021). Contractors shall complete the Worker Protection Investment and Certification Form and submit it with their RFP response.

ENHANCED MINIMUM WAGE PROVISIONS:

Enhanced minimum wage provisions apply to all labor (including contractors and subcontractors) to complete any services and tasks described in the Project Description. Enhanced minimum wage applies when a contractor's employee(s) spends at least twenty percent of their time performing tasks related to the project in a given work week.

- Contractors shall follow and ensure that all subcontractors follow the required enhanced minimum wage provisions outlined below per Pennsylvania's Department of General Services* for all labor.
- Effective July 1, 2025, the enhanced minimum wage rate is \$17.31 per hour (55.Pa.B.2421). An annual cost of living adjustment is applied to the minimum wage rate each July. *All services completed after July 1st must be paid at the new rate.*
- Contractor and all subcontractors will be required to send timesheets/payroll documentation to Chesapeake Conservancy.

*PA Department of General Services Enhanced Minimum Wage Provisions

- a. **Enhanced Minimum Wage.** Contractor/Lessor agrees to pay no less than \$17.31 per hour to its employees for all hours worked directly performing the services called for in this Contract/Lease, and for an employee's hours performing ancillary services necessary for the performance of the contracted services or lease when such employee spends at least twenty percent (20%) of their time performing ancillary services in a given work week.
- b. **Adjustment**. Beginning July 1, 2023, and annually thereafter, the minimum wage shall be increased by an annual cost-of-living adjustment using the percentage change in the Consumer Price Index for All Urban Consumers (CPI-U) for Pennsylvania, New Jersey, Delaware, and Maryland. The applicable adjusted amount shall be published in the Pennsylvania Bulletin by March 1 of each year to be effective the following July 1.
- c. Exceptions. These Enhanced Minimum Wage Provisions shall not apply to employees:
 - 1. Exempt from the minimum wage under the Minimum Wage Act of 1968;
 - 2. Covered by a collective bargaining agreement;
 - 3. Required to be paid a higher wage under another state or federal law governing the services, including the Prevailing Wage Act and Davis-Bacon Act; or
 - 4. Required to be paid a higher wage under any state or local policy or ordinance.
- d. **Notice**. Contractor/Lessor shall post these Enhanced Minimum Wage Provisions for the entire period of the contract conspicuously in easily-accessible and well-lighted places customarily frequented by employees at or near where the contracted services are performed.
- e. **Records.** Contractor/Lessor must maintain and, upon request and within the time periods requested by the Commonwealth, furnish all employment and wage records necessary to document compliance with these Enhanced Minimum Wage Provisions.
- f. **Sanctions**. Failure to comply with these Enhanced Minimum Wage Provisions may result in the imposition of sanctions, which may include, but shall not be limited to, termination of the

- contract or lease, nonpayment, debarment or referral to the Office of General Counsel for appropriate civil or criminal referral.
- g. Subcontractors. Contractor/Lessor shall include the provisions of these Enhanced Minimum Wage Provisions in every subcontract so that these provisions will be binding upon each subcontractor.

INSURANCE REQUIREMENTS:

Prior to executing a contract with the Conservancy, the successful bidder and all subcontractors must obtain the following minimum levels of liability insurance. Contractors who do not carry commercial liability insurance for religious reasons and/or are self-insured should provide applicable documentation with their bid response.

- * Workers Compensation and Employer's Liability can be waived for sole proprietors.
- ** Pesticide Liability can be a standalone policy or an endorsement to the Contractors general liability policy. The Certificate of Insurance must clearly indicate that Pesticide Applications are included in the coverage.

Contractors and subcontractors will be required to include a waiver of subrogation in favor of Chesapeake Conservancy on all liability policies.

"Chesapeake Conservancy" must be named as additional insured on all contractor's and subcontractor's policies except workers compensation.

Contractors shall account for the above noted insurance requirements when submitting their response.

Immediately following the RFP award notification, the successful bidder shall work with their insurance agent to obtain the insurance requirements noted above. The awarded Contractor and all subcontractors shall provide Chesapeake Conservancy with a current COI certified by a licensed insurance broker within 14 days of award notification. The approved COIs need to be provided to Chesapeake Conservancy prior to signing a contract.

<u>Note:</u> Bidders <u>do not</u> need to change their current liability insurance or add additional insured and waiver of subrogation to their policies when responding to the RFP. Only the successful bidder will be required to meet the insurance requirements noted above after the bid is awarded. The Certificate Holder should be as follows: Chesapeake Conservancy, 1212 West Street, Annapolis, MD 21401.

SAFETY PERFORMANCE:

Bidders shall provide safety performance information including OSHA records and EMR on their company and any subcontractors.

OSHA Records:

Contractors whose business is not required to keep OSHA records because they have 10 employees or less should check the applicable box on the Contractor Response Form.

Experience Modifier Rate (EMR):

PENNSYLVANIA COMMERCIAL/PUBLIC PESTICIDE CERTIFICATION:

Contractor must have a current Pennsylvania Pesticide Applicator License and must be certified in the appropriate categories for this project (including some deer repellent applications). It is the contractor's responsibility to ensure proper certifications. Contractor must maintain the license for the term of the contract.

DEBARMENT AND TAX LIABILITY:

Contractors will be required to certify that they and any subcontractors are not listed on the Debarment and Suspension List maintained by the Pennsylvania Department of General Services (https://www.dgs.internet.state.pa.us/debarmentsearch/debarment/index) and the General Services Administration's List of Parties Excluded from Federal Procurement or Nonprocurement Programs (www.SAM.gov) in accordance with Executive Orders 12549 and 12689, "Debarment and Suspension" and have no outstanding tax liabilities. Contractors will also be required to certify that they and any subcontractors are not in default of a loan or funding agreement administered by any Commonwealth agency.

SMALL BUSINESS AND SMALL DIVERSE BUSINESS:

Chesapeake Conservancy encourages the use of small and small diverse businesses when soliciting Requests for Proposals. Contractors are encouraged to register with the federal government at www.sam.gov and with the Pennsylvania Department of General Services at www.dgs.pa.gov (search Small Diverse Business Verification). Please note Pennsylvania Department of General Service registration is only valid for three years. Contractors are encouraged to verify that their registration is current.

Contractors and any subcontractors who register on Sam.gov and with the PA Dept of General Services and who qualify as a small and/or small diverse business should check the applicable boxes on the Contractor Response Form. Points will be awarded as per the scoring sheet in Attachment D to contractors whose registration is confirmed by Chesapeake Conservancy.


