

## Playaway Products Launchpad Quest Three-Year Limited Warranty

**Playaway's warranty obligations for the Launchpad Quest product are limited to the terms set forth below:**

When delivered to you in a new condition in its original container, Playaway Products warrants the Launchpad Quest device against defects in materials and workmanship for a period of three (3) year from the date of original purchase ("Warranty Period").

If a defect arises and a valid claim is received by Playaway within the Warranty Period, as its option, Playaway will (1) repair the product at no charge, using new or refurbished replacement parts, (2) exchange the product that is new or which has been manufactured from new or serviceable used parts and is at least functionally equivalent to the original product, or (3) refund the purchase price of the product.

Playaway warrants replacement products or parts provided under this limited warranty against defects in materials and workmanship from the date of the replacement or repair of ninety (90) days or for the remaining portion of the original product warranty, whichever provides longer coverage for you. When a product or part is exchanged, any replacement item becomes your property and the replaced item becomes Playaway's property. When a refund is given, your product becomes Playaway Products' property.

### Exclusions and Limitations

This Limited Warranty does not apply to any non-Playaway hardware product, even if packaged or sold with the Launchpad Quest product, including, without limitation, the power adapter. Non-Playaway manufacturers or suppliers may provide a separate warranty for their own products packaged with the Launchpad Quest product.

**This limited warranty covers all defects encountered in the normal use of the Launchpad Quest product, and does not apply in the following cases:**

1. Loss of or damage to the Launchpad Quest product due to abuse, mishandling, improper packaging by you, alteration, accident, electrical current functions, failure to follow operating instructions prescribed in Playaway's user's manual or services performed by someone other than Playaway or an authorized Playaway service provider. Without limiting the foregoing, water damage, sand/corrosion damage, battery leakage, dropping the Launchpad Quest product's body, buttons or display, or damage to accessories set forth above, will be presumed to have resulted from misuse, abuse or failure to operate the Launchpad Quest product as set forth in the operating instructions.
2. Use of parts or supplies (other than those sold by Playaway) that cause damage to the Launchpad Quest product or cause abnormally frequent service calls or service problems.
3. If the Launchpad Quest product has had its serial number altered or removed.

- Operate in a place where temperature is always between 44° and 104°F (7° and 40°C). Never leave your video player inside an automobile. Temperature in parked automobiles can exceed this temperature range.
- Do not block any ventilation openings. Install in accordance with the manufacturer's instructions.
- Do not install near heat sources such as radiators, heat registers, stoves, or other apparatus (including amplifiers) that produce heat
- Unplug this apparatus during lightning storms or when unused for long periods of time
- Refer all servicing to qualified service personnel.
