## IRS SPECIAL AGENT RESIGNS after exposing rouge agency as unlawful, tyrannical, hypocritical

**"I Cannot Serve Two Masters" — Joseph R. Banister**

### Special Report

Joe Banister is, or more accurately was, an IRS Special Agent working in the Criminal Investigation Division of the Internal Revenue Service.

20 months ago, Joe began to communicate with several "tax protesters." In a rare occurrence, representatives from *Freedom Law School* and the *Free Enterprise Society*, along with patriots Bill Conklin, Attorney Larry Becraft, Devvy Kidd and Bill Benson were able to convince Joe (whose job it was to put people like them in jail) to actually evaluate the information that was so objectionable to the IRS.

For the next 14 months, Joe poured over the information. In early February ('99), he submitted a 90 page report to his superiors at the Internal Revenue Service. In his report, Joe informed his superiors that he had found the following information to be legally accurate and factual.

The following is just a partial list of his findings:

1) There is no federal law requiring an American Citizen, working and living in one of the 50 states, to file an income tax return or pay income tax.

2) The 16th Amendment did not provide Congress with any new taxing authority, but merely reversed an earlier US Supreme Court decisions, thus placing the income tax forever within the category of a "privilege tax" (i.e. a

tax for doing something that you have no natural right to do as a Citizen).

3) The so-called 16th Amendment was never properly ratified and therefore, having never received the blessings of the 20 Union states, it is only a federal law which applies to Washington D.C. and its territories.

4) The United States operated each year EXCLUSIVELY by loans provided by the Federal Reserve (which is a 100% private banking institution and is not a government agency) and not one penny of income tax goes to the US Treasury, but rather 100% of the tax collected goes directly to the Federal Reserve banks. In short, the IRS acts EXCLUSIVELY as the collection department of the Federal Reserve banking system.

The following is a recent e-mail to the Patriots he now considers his friends.

Dear Friends:

Well, the day of reckoning has arrived. On February 11, 1999, in my capacity as a Special Agent and federal law enforcement officer sworn to support and defend the Constitution of the United States, I submitted a "preliminary report" to the Chief of the IRS Criminal Investigation Division for the Central California District. My report summarized my findings regarding allegations that the income tax and filing of federal income tax returns is volun-

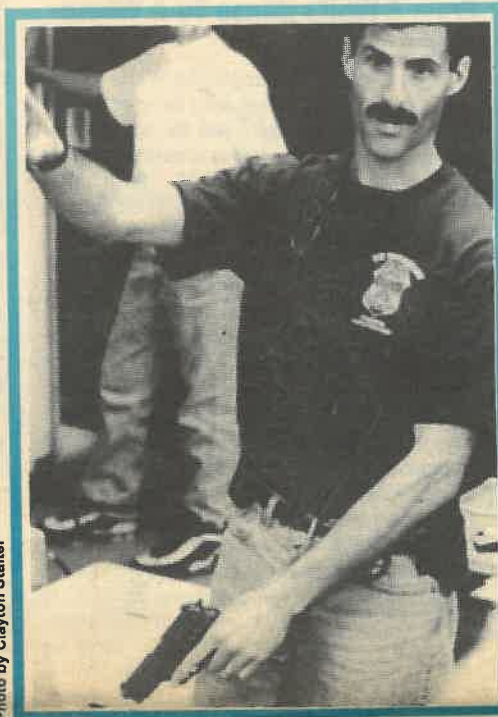

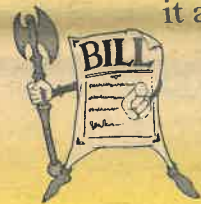

## U.S. Government vs. Christendom

### The Free Congress Commentary

Once again, the U.S. government is siding with Moslems against Christians. The place is again the Balkans, where we are supporting the Islamic Albanians' grab for Kosovo, the historic heartland of the Christian Serbs. We did the same thing in nearby Bosnia, where we again supported Moslems against the Serbs, including by bombing Serbian forces. I wonder how many American Christians have thought about the fact that their defense dollars now go to attacking other Christians on behalf of Islam?

Over and over again, the U.S. government has showed a bias against Christianity and in favor of Islam. In Africa, where thousands of Christians have been martyred at the hands of Islamics, our government has maintained a careful silence. The same is true in Indonesia, where much of the recent rioting has been directed against Christians.

Perhaps the most grotesque example is Saudi Arabia, a country we fought to defend against Iraq in the Gulf War and also a country where anyone who converts to Christianity is beheaded. (In contrast, Iraq's current foreign minister is a Christian). The U.S. State Department is so anxious to kiss the Saudis' robes that it banned Christian religious services at the U.S. consulate in Jeddah. Those services had given American citizens in Saudi Arabia a place to worship. All Christian services are illegal in Saudi Arabia, but the consulate is legally American soil, so the Saudis could not stop them. The consulate offered weekly Protestant and Mormon services as well as Catholic Mass. Until, that is, the State Department

had the bright idea that it could please its Saudi patrons by halting the Christian services. So determined was it to do so that when a Foreign Service officer, Timothy Hunter, protested the action, he was promptly dismissed from the service. The official reason for his firing was that he had not "absorbed the Foreign Service culture," a culture in which everything American is subordinated to whatever some foreign panjandrum wants. To his credit, Mr. Hunter has initiated legal action against the State Department over his dismissal.

Meanwhile, the same U.S. consulate in Jeddah where Christian worship services are forbidden offers an Islamic service five times a day. You read it right the first time: that is in a United States consulate.

There is a term for this behavior: cultural treason. Islam and Christendom are at war, as they have been ever since Islam first appeared in the seventh century. In war, someone who turns against his own side and intentionally aids the enemy is a traitor. Just as the State Department was full of Marxists in the early days of the Cold War (Herbert Marcuse of Frankfurt School fame was one of them), so now it is full of "multiculturalists" as we move into a world of cultures in conflict.

Where's Joe McCarthy when we really need him? □

## IRS Special Agent Forced to Resign After Challenging Superiors with Truth about income tax fraud.

tary, that the 16th Amendment was never ratified, and that income taxes are not used to pay for daily government operations.

In order to ensure that unnecessary and unwarranted delay would not occur, I requested that my report be forwarded to top officials in the IRS up to and including Commissioner Charles O. Rossotti, and I respectfully requested that the Commissioner or his designee respond to the evidence in my report within 30 days. Today, my Chief called me into his office and gave me a memorandum. The memorandum dated February 17th, 1999, read in part:

*The Internal Revenue Service will not be responding to your request and will provide you with the necessary paperwork to tender your resignation. You will be placed on administrative leave effective upon receipt of this memorandum for a period of seven calendar days to consider what actions you wish to take.*

I was told that officials at the highest levels of the Internal Revenue Service were consulted regarding a response to my report. Apparently, I have now joined the ranks of every other taxpayer who ever was ignored or otherwise rebuffed by the Internal Revenue Service when they petitioned the IRS for a reasonable explanation.

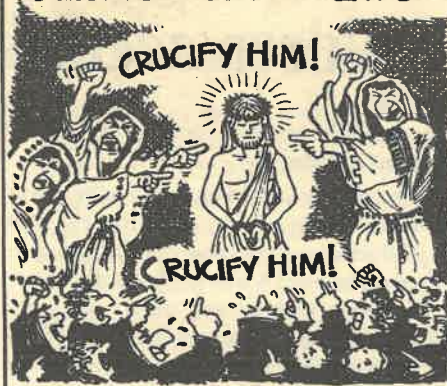
The only conclusion that I can reach is that those officials thought it was better to rebuff my request and pass up a golden opportunity to prove my research wrong than to have to admit that so-called "tax-protesters" and other supporters of the U.S. Constitution have been right all along. Ironically, had the IRS taken the time to address my concerns, or perhaps perform the simple task of proving the allegations wrong, I would have gladly been their spokesman advising taxpayers not to fall for these untrue allegations for the rest of my career.

As the memorandum states, I have until Friday, February 26th, 1999, the day after the 86th anniversary of the alleged ratification of the 16th Amendment, to tender my resignation. (Mr. Banister resigned February 25th) This is certainly a sad day in my life. Although I was hoping for a better result, I learned today after over two years of investigation that the Internal Revenue Service is everything the so-called "tax protesters" said it was; non-responsive, unable to withstand scrutiny, tyrannical, and an agency oblivious to the rule of law and the U.S. Constitution.

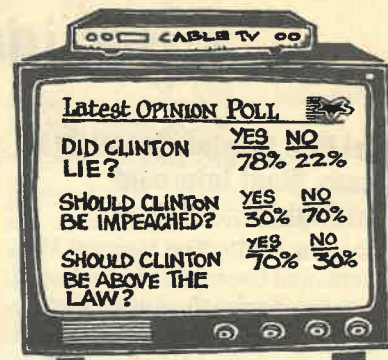

In an interview with *The Jubilee Newspaper*, Joe says he feels "embarrassed" that he had been suckered by the lies foisted upon the public at large by the government. "I went into the IRS not trusting the government," he said, "I was naive because I thought I could change it." Joe says perhaps he can do that now that he is on the outside.

Joe states the IRS uses fear and intimidation to coerce Americans into "volunteering" to pay the unconstitutional income tax. While he is careful not to advise people to NOT file he warns, "use your rights, don't waive any of them." He emphasized, "I have not found that they [IRS] have the legal authority to do what they do, they just have lots of guns and lots of lawyers and as long as people think that they are out numbered the IRS will continue to come out on top."

Joe points out that the IRS only has roughly 3,000 special agents and only 100,000 employees in the nation — a small percentage compared to the hundreds of millions of taxpayers. He notes that each special agent can only handle one case a year. "Do the math" he added.

Asked why he didn't stay in the IRS and try to do some good, he said that he would have surely been the target of a set-up such as a drug planting or some other nasty method that would have resulted in his expulsion and subsequent loss of credibility. He would have had to remain completely silent about his new found knowledge or completely repudiated the truth he learned in order to stay an employee.

"In order to keep my oath of office (to uphold the constitution) "I had to resign" Joe said. "I could not serve two masters."

Joe says his job became pretty apparent, and that was to be the first special agent to confront the IRS and say, "look, what I've seen you do is ignore people, audit people and prosecute people [everything] except for answering people's very legitimate questions. And now you have a sworn Federal law enforcement

officer looking you in the eye and saying I've got those same questions which I spent two years researching, what are you going to say to me?"

Their answer, ignored him. "They didn't have a leg to stand on," Joe remarked, "the only leg they have is pointing a gun at your head. ... I agree with the American founders, *Live Free or Die!*"

Joe's investigation culminated in a 90 page preliminary report: "Investigating the Federal Income Tax" which he presented to his superiors (as noted above) in it he investigated three allegations which he heard Patriot Devvy Kidd asserting on a talk radio show out of San Francisco in 1996.

1. Filing income tax returns is voluntary.
2. The 16th Amendment was never legally ratified and,
3. The government operates using fiat money, not with revenue from income taxes.

While the book is not an exhaustive study, it provides ample evidence to cause one to seriously rethink the oxy-moronic "vol-

untary compliance" language of the Internal Revenue Code — among many other IRC lies. Perhaps it's most valuable asset however, is not its incredible contents but who its author is!

After the talk show Joe ordered Devvy Kidd's booklet "Why a Bankrupt America" which provided him with contacts to other so-called dangerous "illegal tax protesters." He began interviewing and reading everything he could get his hands on until finally his conscious and oath of office — which he took seriously — caused him to confront his superiors.

"The truth is truth," Joe told *The Jubilee*, "you are either going to stand up for it or you are going to put the blinders on." Joe chose to stand. □
