A Visa Application Form BI-84

Fully completed, in black ink only.



A Valid Passport

Your passport must be valid at least six (6) months after the intended stay, and stlll have at least two (3) blank pages for stamps.



Passport-sized Photographs

You must submit two passport-sized photographs that meet the following requirements:

- Two identical passport size (35mm width x45mm heigth) photographs on white background showing the complete face.
- They must be in colour.
- Your face must be clearly visible from the front.
- Your eyes must be open.
- You must not be wearing sunglasses, a hat, or a scarf.



A Copy of Passport Data Page

The passport data page is the one having the holder's personal data, photographs, and data concerning issue and validity. You must also provide copies of existing visa and previously issued visas.



A Proof of Financial Status or Employer Support Letter

Both proof of financial status and financial support letter from employer - in case where the employer is sponsoring the trip - with can be made with three (3) months bank statement (original, stamped & signed by the bank authority). In the event the applicant is travelling on a private capacity, the bank statement submitted should reflect the salary deposited into the applicant's bank statement. Sponsored trips should always have a letter with full details of the sponsor and contact details; as well as a copy of identity card/passport data page. Certain corporate entities are exempted from this requirement.

With physical address and phone number.



A Recommendation Letter From Your Employer (where applicable) Signed with contact details: full names of the Employer's, approved signatories, physical address and phone numbers.

A Flight Booking Confirmation With a return ticket. All verifiable bookings are required and should be submitted together with the application.

A Verifiable Hotel Reservation The booking must be done directly with the hotels and not through third parties, (e.g. booking .com; hotel .com, HRS, etc). All verifiable bookings are required and should be submitted together with the application.

The Invitation Letter from Simaero

The invitation letter must be issued by Simaero South African legal entity: SIM Aerotraining (Pty) Ltd.

Other Documents Related to Your Training

- A copy of the proforma invoice with the deposit paid
- The planning of the training
- The Simaero Terms and Conditions of Training and Services contract signed by both parties.

Other documents

You may also be asked to provide other documents, such as a birth certificate, marriage certificate, or divorce decree.

A Copy of International Travelling Certificate

(yellow fever card) duly and fully completed by a health practitioner. The copy must be in colour.
