District 4: Heather Chapman is new detention supervisor. Supervisor and 2 PO positions are open. **District 5**: Detention looking for female officer. Cases are getting harder and younger. Hiring new PO.

District 6: Matt Harden updated on crisis resources from Magellan.

District 7: Hiring new Magistrate Judge in Bonneville County.

Tribal: North: Looking for chief judge, hired diversion coordinator and already has 5 kids. More inappropriate social media going around. South: Anissia did tour of Ft. Hall. No juvenile residents, 35 adults. 35 certified staff and 3 more getting certified. Working on community program to get people out of their houses – Anger Management for teens and adults, Smudges and tribal court.
