RISKS OF PARTICIPATION

PERMISSION & LIABILITY WAIVER

In consideration of my child's participation, I agree to:

- **Assume all risks** (known or unknown)
- **Waive all claims** against ReNEW Schools, staff, trustees, volunteers, and affiliated parties (the "Releasees") for injury, illness, death, or property loss except in cases of **gross negligence**
- **Indemnify and hold harmless** the Releasees for any claims made by or on behalf of my child or caused by my child
