Businesses that sell food and drinks and have onsite dining must provide **recycling** and **organics** containers for their customers.

- Place containers next to the trash can where everyone can see them and get to them easily. Make sure they are labeled clearly

Keep it clean and avoid a **contamination fee**.

Let's Keep It Clean: Only Approved Bags in Green Bins!

ORGANIC waste must be placed only in approved (**clear plastic**) bags. Using the correct bags is essential for effective waste management and protecting environmental sustainability.



THE ISSUE WITH NON - CLEAR BAGS

- The composting facility where we take our **organic** material does not accept or open non-approved bags due to potential contaminants.
- Contaminants in bags could ruin an entire truck load.
- When non-approved bags are in an **organics** bin, they are sent to the landfill instead.
- Extra fees are charged for the trash removed from the **organics** load, and these additional costs affect our rates and, ultimately, your rates.
