Some links on YFMusic+ are paid affiliate links. If you follow one and make a qualifying purchase, YFM+ may receive a commission. YFM+ does not add an affiliate fee to your order. Eligible members may also earn YFM Points, subject to tracking, retailer validation and the YFM+ Terms.

YFM Plus Pty Ltd (ABN 34 671 082 947) operates YFMusic+ (YFM+, we, us or our). This Affiliate Disclosure explains our commercial relationship with Partner Stores and affiliate networks, and how that relationship interacts with YFM Points.

1. What is an affiliate link?

An affiliate link is a tracked link to a third-party retailer, service or other commercial partner (a Partner Store). It can contain or create an identifier that allows the Partner Store, an affiliate network or an attribution provider to recognise that a visit or purchase came from YFM+.

We may label these links or buttons as 'Paid link', 'Affiliate link', 'Partner Store' or with another clear notice stating that YFM+ may earn a commission. A label is intended to alert you to the commercial relationship before you decide whether to click or buy.

2. How YFM+ may benefit

If you click an affiliate link and complete a qualifying purchase or other qualifying action, YFM+ may receive a commission, referral fee or other benefit from the Partner Store or affiliate network. Commission income helps fund the Platform, artist promotion, member features and rewards.

YFM+ does not add an affiliate fee to your transaction. The Partner Store controls its prices, discounts, fees, availability and sale terms. A commission will not ordinarily increase the price displayed by the Partner Store, but prices and offers can differ by location, device, account status, timing or retailer rules.

3. YFM Points from Partner Store activity

Eligible members may earn YFM Points for qualifying Partner Store purchases. The applicable earning rate or plan multiplier will be shown on YFM+ or in the current Terms. Relaunch V3 currently uses the following plan multipliers:

- Basic+: standard Partner Store Point rate;
- Plus: 2x the standard Partner Store Point rate; and
- VIP: 5x the standard Partner Store Point rate.

YFM Points are loyalty points used within YFM+. They are not cashback, money, a bank deposit or a direct share of the commission YFM+ receives. The commission earned and the Points awarded may be calculated differently.

Points are normally added only after the relevant Partner Store or network tracks and validates the transaction. Validation can take time. A click, purchase confirmation or payment does not itself guarantee that Points will be awarded.

4. Tracking and attribution

YFM+ currently uses or may use attribution services including AnyTrack while enabled, together with affiliate networks such as Rakuten Advertising, Impact and Awin. The retailer, network or attribution provider may use cookies, pixels, referral parameters, browser or device identifiers and transaction references to connect a qualifying action to YFM+ and, where possible, to the correct member account.

Tracking may fail where cookies or identifiers are blocked, rejected, overwritten or deleted; where another website or code receives the last eligible referral; where the purchase occurs outside the tracking window; or where the Partner Store does not report the transaction. Our Privacy Policy explains the related collection, use, disclosure and overseas processing of personal information.

5. What is a qualifying purchase?

A qualifying purchase must satisfy the rules of YFM+, the Partner Store and the relevant affiliate network. Requirements can vary by merchant and offer. Unless stated otherwise, a purchase may be excluded, delayed or reversed where:

- the affiliate link was not used, attribution was lost, or the purchase was not reported to YFM+;
- the order was cancelled, returned, refunded, charged back, duplicated, fraudulent or otherwise invalid;
- a coupon, discount, gift card, subscription, product category, tax, delivery charge or other component is excluded by the Partner Store or network;
- the transaction occurred outside the eligible country, account, campaign or tracking window;
- the user was not signed in or the transaction could not reasonably be matched to the member account; or
- the activity breached the YFM+ Terms, the Partner Store's terms or applicable law.

If Points were added before a transaction was finally validated, YFM+ may correct or reverse them after a return, refund, cancellation, chargeback, tracking adjustment or fraud review. Contact support if you believe a qualifying transaction is missing and provide only the information reasonably requested to investigate it.

6. Our recommendations and editorial approach

A Partner Store's inclusion on YFM+ may be influenced by a commercial relationship, expected commission, member relevance, product range or campaign availability. We aim to make the

commercial relationship clear and to avoid presenting paid placement as an independent recommendation where it is not one.

An affiliate link does not mean that YFM+ guarantees, certifies or endorses every product, service, claim or seller on the linked website. You should consider your own needs, compare alternatives and review the Partner Store's current product information before purchasing.

7. Third-party purchases

When you follow a Partner Store link, you leave the YFM+ Platform and deal directly with the Partner Store. The Partner Store is responsible for its website, products, pricing, stock, payment processing, delivery, returns, warranties, customer service and privacy practices. Its own terms and privacy policy apply.

Unless YFM+ expressly states otherwise, YFM+ is not the seller, supplier or fulfilment provider for a Partner Store purchase. Nothing in this disclosure excludes rights or remedies that cannot lawfully be excluded under the Australian Consumer Law or another applicable law.

8. Sponsored, gifted and promotional content

YFM+ may also receive payment, free products, services, access, discounts or another benefit to create or publish particular content. Where that relationship could affect how a reasonable person understands the content, we will use a clear disclosure such as 'Ad', 'Sponsored', 'Gifted' or an equally clear explanation near the content.

A disclosure on this page does not replace a disclosure beside the relevant post, recommendation, button, video or link. We will not rely only on vague terms such as 'collab', 'partner' or an unexplained abbreviation where the commercial nature of the content would not otherwise be obvious.

9. Short disclosures used across YFM+

Depending on the space and format, YFM+ may use wording such as:

- Website or email: 'Paid link: YFM+ may earn a commission if you make a qualifying purchase through this link. Eligible members may also earn YFM Points, subject to the YFM+ Terms.'
- Short label: 'Paid link - YFM+ may earn a commission.'
- Social post: 'Ad / affiliate link: YFM+ may earn a commission if you buy through this link.'
- Gifted content: 'Gifted: YFM+ received this product or service at no cost.'

The wording may change to suit the channel, but the disclosure should remain easy to notice and understand before or at the point a person engages with the commercial content.

10. Changes to this disclosure

We may update this Affiliate Disclosure when our Partner Stores, networks, attribution tools, Point rules, commercial arrangements or legal obligations change. The updated disclosure will show its effective date and be published on the Platform.
