Paul has also given expert oral evidence in the Royal Court of Jersey (criminal proceedings). He has also acted as a nautical assessor to the High Court of Hong Kong. Paul has also been the Hong Kong Government Nautical Adviser 2015 to 2018.

Investigations and expert reports have been carried out for collision incidents, unsafe ports/berths, groundings and vessel damage and repair, cargo worthiness and cargo securing, steel replacement surveys (Hull and Machinery), container loss and damage, cargo damage including steel products (on and under deck), heavy lifts, timber deck cargoes, logs (on and under deck), cargo fires, fertiliser and grain

cargo contamination including damaged and wetted bulk cargoes. He has also carried out instructions on navigation, unseaworthiness, personal injury cases and ISM and ISPS related issues.

His practical experience of the ISM and ISPS codes, having produced company Safety Management Systems (SMS), Ship Security Assessments (SSA) and Ship Security Plans (SSP), as well as managing and auditing them has been utilised in a number of ISM and ISPS related cases leading to the giving of oral expert evidence in arbitration.

His experience of the International Maritime Solid Bulk Cargoes Code (IMSBC) has involved investigation of the liquefaction of mineral ores as well as coal and bauxite cargoes. In particular, he has provided expert advice on coal, direct reduced iron (A) and (B), ammonium nitrate, and other MHB and DG bulk cargoes.

He has carried out accident investigations on behalf of Malta Transport (affiliated to the Maltese Flag State).

As a consultant, and as a marine surveyor, he has carried out numerous H&M and condition surveys of various vessel types on behalf of shipowners and offshore contractors. As a Marine Warranty Surveyor, he has been involved with subsea construction projects for oil majors in Europe and West Africa involving dynamically positioned heavy lift and construction vessels, transportation of topsides and their installation and towage approvals. He has also carried out instruction in the renewables sector for the marine transportation of wind farm turbines (nacelles), transition pieces, towers, and blades together with the installation of wind turbines.

In addition, he has carried out suitability surveys on Dynamically Positioned (DP) heavy lift and construction vessels, dive support vessels, dredgers, multipurpose fall-pipe rock dumping vessels, jack-ups, supply vessels, deep sea tugs and anchor handling vessels and cable laying vessels and barges.

As the technical team leader and Deputy DPA, he was responsible to the Commercial General Manager for the safe technical management of a fleet of British registered RoRo and Ropax vessels operating in the North Sea and Mediterranean.

Responsibilities included day to day technical management and exchanges with the Maritime Coastguard Agency (MCA), Flag State and Classification Societies ensuring the fleet met all statutory and commercial requirements for safe operation.

He was also responsible for the day to day operation of CSVs and DSVs operating out of Aberdeen. Duties included onboard training and conducting internal ISM and ISPS audits as Deputy DPA, also liaising with the UK Health and Safety Executive (UKHSE) when carrying out incident and accident investigations.

For a period of two years, he was also the general manager for Massoel Meridian (Geneva), a joint venture company with Meridian Marine Management. The role involved direct responsibility to the CEO for the overall technical management of a fleet of, Swiss owned, geared bulk carriers. A full Safety Management System (SMS) and associated security procedures was prepared, as required for the implementation of the ISM and ISPS codes. The post also included the role of DPA/CSO and Director in charge of the Emergency Response Team. He was also a member of the BIMCO anti-piracy working group.

During 2006, he was seconded to Doha, Qatar, being responsible for the operation of self-propelled and towed jack-up rigs, liaising with the various clients and for technical, crewing and safety personnel.

As the Marine and Safety Manager for Meridian Marine Management and Indo China Ship Management he was responsible for a number of different vessel types. Initially for, a fleet of LPG/C and chemical tankers, container vessels and bulk carriers. Latterly, offshore vessels were added, including CSVs, DSVs and self-propelled/towed jack-ups. His role included safe operations, including compliance for MARPOL 73/78, SOLAS and flag state requirements including arranging and

monitoring SIRE II, CDI, offshore client inspections and all associated follow-up and close-out operations.

The role also involved the setting up of OPA 90 and California Contingency Plans for each vessel, as well as being a key member of the Emergency Response Team. As Deputy DPA, Internal ISM/ISPS (2004 onwards) auditing was conducted for the fleet including third parties.

As a qualified lead auditor, he has also conducted HSE audits of a number of dry docks worldwide.
