What is SB179?

In 2021, Texas passed Senate Bill 179, requiring school counselors to spend at least 80% of their work time on activities that are part of a comprehensive counseling program—like academic advising, career planning, and mental health support.

The challenge? Districts must now track, report, and prove that their counselors are spending time where it matters—not on lunch duty or test coordination.

What SB179 Requires

- 80/20 Rule: Only 20% of counselor time can be spent on non-counseling tasks
- Time Tracking: Schools must document how each counselor spends their time
- District Accountability: Compliance reporting is required and auditable
