

OFFICIAL RULES — JusCollege Back to School Vegas Giveaway

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. Sponsor

CVJV LLC d/b/a JusCollege, 7165 Rafael Ridge Way, Las Vegas, NV 89119 ("Sponsor").

This promotion is in no way sponsored, endorsed, administered by, or associated with Instagram or Meta Platforms, Inc. ("Instagram"). Entrants release Instagram completely and agree that any questions, comments, or complaints regarding the promotion must be directed to Sponsor, not Instagram. By entering, you agree to Instagram's Terms of Use.

2. Eligibility

Open to legal residents of the fifty (50) United States and the District of Columbia who are twenty-one (21) years of age or older as of the date of entry. Void in Puerto Rico, all other U.S. territories and possessions, and wherever prohibited or restricted by law.

Employees, officers, and directors of Sponsor and its parent, affiliates, subsidiaries, advertising and promotion agencies, and prize suppliers, and the immediate family members and household members of each, are not eligible.

Entry is **not** limited to individuals who have booked travel with Sponsor. No purchase, booking, or payment is required to enter or to win. Winners who have not booked the Trip will receive the alternate prize described in Section 5.

3. Promotion Period

The promotion runs from September 14, 2026 through October 1, 2026 and consists of **three (3) separate entry periods**, each with its own prize and its own winner:

Sponsor's computer is the official time-keeping device. Each entry period opens on a Monday and closes the following Wednesday at 11:59:59 PM PT. No entry period is open from Thursday through Sunday of any week. Comments posted on a giveaway post outside the open entry period for that post — including after that period has closed or before the next has opened — are not eligible entries, will not be considered for any entry period, and will not roll forward. Entries submitted during one entry period are not carried into any other entry period.

One prize per person. An entrant may enter all three (3) entry periods, but may win only one (1) prize across the entire promotion. A confirmed winner of any entry period is not eligible to win a later entry period; if such a person is drawn in a later period, that entry will be disregarded and an alternate selected.

4. How to Enter

During each entry period, visit the corresponding giveaway post on Sponsor's Instagram account, @juscollege, and:

1. **Follow** @juscollege on Instagram; and
2. **Like** that week's giveaway post; and
3. **Comment** on that week's giveaway post, tagging at least one (1) other Instagram user in your comment.

Each qualifying comment on a given week's post constitutes one (1) entry for that week's prize. There is no limit on the number of qualifying comments an entrant may post during an entry period.

Postcards must be handwritten, must designate which entry period (Week 1, Week 2, or Week 3) the entrant wishes to enter, and must be received by 11:59 PM PT on September 30, 2026. A postcard designating an entry period that has already closed at the time of receipt will be entered into the next open entry period.

Entries must not contain content that is obscene, defamatory, harassing, discriminatory, unlawful, or that infringes any third party's rights. Sponsor may disqualify any entry in its sole discretion. Entries generated by script, bot, macro, or any automated means, and entries from accounts created for the purpose of entering, are void.

5. Prizes

"Trip" means the Las Vegas Senior Trip, running on the first three (3) weekends of October 2026 (between October 1 and October 19, 2026). Each departure runs either Thursday through Sunday or Friday through Monday, as specified in the traveler's booking. Where a prize is tied to the Trip, it applies to the specific departure and dates on which the winner is booked.

Week 1 — Suite Upgrade. One (1) winner. Upgrade to a suite at the property at which the winner is booked for the Trip, subject to availability and to the property's terms and policies. Prize value: \$1,500. If the winner's booked property does not offer a suite, or no suite is available for the winner's dates, Sponsor will substitute the best available upgrade at that property or an alternate prize of comparable value, in Sponsor's sole discretion. Total ARV including airport transfer: \$1,650.

Week 2 — VIP Table and Party Bus. One (1) winner. VIP table service at a venue selected by Sponsor and party bus transportation for the winner plus nine (9) guests during the winner's Trip dates. The venue and event will be determined by Sponsor based on the winner's trip itinerary and announced to the winner approximately one (1) week prior to the Trip. Table service includes one (1) table seating ten (10) guests, venue credit in the amount equal to two (2) bottles, and gratuity; it does not include additional bottles, food, or incidentals. Any amount in excess of the credit, and all food, beverages, and incidentals not covered by the credit, are the winner's responsibility. All beverage service is provided by the venue in its sole discretion, is subject to the venue's licensing obligations and service policies, and requires valid government-issued photo identification. No alcoholic beverages are included as part of the prize. Prize value: \$2,000. Total ARV including airport transfer: \$2,150.

The party bus and table reservation will be held in the winner's name, and the winner must be present. All nine (9) guests must be twenty-one (21) years of age or older and confirmed booked travelers on the Trip for the applicable dates. Guests who cannot be verified may be refused entry by the venue or transportation provider. No substitution or cash value for unused guest slots.

Week 3 — Trip Refund for Two. One (1) winner. Reimbursement of the winner's paid trip package cost and the paid trip package cost of one (1) guest, for the Trip, up to a maximum of \$499 per person. The guest must be a confirmed booked traveler on the same departure. Refunds will be submitted for processing within one (1) week of the winner announcement and will post to the original method of payment within seven to ten (7–10) business days after processing. Prize value: up to \$998 total. Total ARV including airport transfer: \$1,150.

VIP Airport Transfer — included with every prize

Each weekly prize additionally includes one (1) one-way VIP airport transfer from Harry Reid International Airport (LAS) to the winner's hotel on the winner's scheduled arrival date, for the winner and up to three (3) travel companions arriving at the same time. ARV: \$150. Return transportation to the airport is not included.

To claim the transfer, the winner **must book it directly with our transportation partner using the reservation link and unique promo code Sponsor provides at winner verification.** The promo code is issued to the winner alone, is non-transferable, and is valid for a single booking. Bookings placed without that link and promo code are not part of the prize and are the winner's own expense.

Booking deadline: 11:59 PM PT on the day immediately preceding the winner's scheduled arrival date. The promo code expires at that deadline. A transfer not booked by the deadline is forfeited in its entirety, has no cash value, will not be reissued, rescheduled, or substituted, and does not increase the value of any other prize element.

The winner must supply complete and accurate flight information (airline, flight number, and scheduled arrival time) at the time of booking. Transfer service is subject to that provider's terms, capacity, luggage limits, and service area. Sponsor is not responsible for delays, cancellations, missed pickups, or additional charges resulting from flight changes, inaccurate flight information, late arrival at the pickup point, excess luggage or passengers, or acts of the provider.

Winners who have not booked the Trip. Each prize in this promotion is tied to travel on the Trip. If a winner is not a confirmed booked traveler on the Trip as of winner verification, that winner will instead receive

Week 1 — Alternate Prize: one (1) prepaid card in the amount of \$1,650. ARV: \$1,650.

Week 2 — Alternate Prize: one (1) prepaid card in the amount of \$2,150. ARV: \$2,150.

Week 3 — Alternate Prize: one (1) prepaid card in the amount of \$1,150. ARV: \$1,150.

No other substitution will be made, and the winner may not transfer the prize to a person who is booked on the Trip.

All prizes. Total ARV of all prizes: \$4,950. Prizes are awarded "as is" with no warranty of any kind. Prizes are non-transferable and may not be substituted, exchanged, or redeemed for cash, except that Sponsor reserves the right to substitute a prize of equal or greater value if the advertised prize becomes unavailable. All expenses and costs not expressly listed above are the responsibility of the winner. Winners and guests must possess valid government-issued photo identification and must comply with all venue, property, transfer provider, and Sponsor trip policies; failure to do so may result in forfeiture without compensation.

Prizes must be used on the winner's specified Trip dates only and have no value outside them. Unused prize elements are forfeited.

6. Odds

Odds of winning depend on the number of eligible entries received during the applicable entry period.

7. Winner Selection and Notification

Following the close of each entry period, Sponsor will export all qualifying entries for that period and select one (1) potential winner in a random drawing, along with two to three (2–3) alternates. Drawings will be conducted on or about September 17, September 24, and October 1, 2026, respectively, by Sponsor, whose decisions are final and binding in all matters relating to this promotion.

Potential winners will be verified for compliance with these Official Rules — including that the winner is twenty-one (21) or older and has not already won an earlier entry period. Drawings will be conducted on the morning of the announcement date. Potential winners will be notified by Instagram direct message from @juscollege and asked to reply with an email address; verification and tax information are then collected by email. Potential winners must respond with the requested information within twelve (12) hours of notification. Sponsor will announce the winner in a post on @juscollege on the announcement date or promptly after verification is complete.

The winner of each entry period will be announced in a post on @juscollege on or about September 17, September 24, and October 1, 2026, respectively.

A potential winner will be disqualified and an alternate selected if the potential winner: fails to respond within the stated period; is found ineligible; does not follow @juscollege at the time of drawing; cannot be verified; declines the prize; or fails to provide the information requested above. Sponsor is not responsible for direct messages that are filtered, blocked, or otherwise not received.

No signed affidavit or release is required from the winner. Acceptance of a prize constitutes the winner's agreement to these Official Rules, including the release and limitation of liability in Section 10 and the publicity consent in Section 9. Guests, venues, and the transfer provider may separately require waivers or releases of their own as a condition of participation or service.

8. Taxes

All federal, state, and local taxes on prizes are the sole responsibility of the winner. Because the ARV of each prize in this promotion exceeds \$600, each winner will be required to provide a valid Social Security number or taxpayer identification number and will be issued an IRS Form 1099-MISC for the ARV of the prize. A winner who declines to provide a taxpayer identification number will forfeit the prize and an alternate will be selected.

9. Publicity

Sponsor is not responsible for: lost, late, incomplete, garbled, or misdirected entries; technical or human error of any kind; interruption or unavailability of Instagram or any network; unauthorized intervention in the entry process; or any injury or damage to any person's device related to participation.

Sponsor reserves the right to cancel, suspend, or modify the promotion, in whole or in part, if fraud, technical failure, or any other factor beyond Sponsor's reasonable control impairs its integrity or proper functioning. In such event, Sponsor may award prizes at random from among eligible entries received prior to the impairing event.

Entrants agree that any dispute shall be resolved individually, without resort to any form of class action, exclusively in the state or federal courts located in Clark County, Nevada, and entrants consent

to the jurisdiction of such courts. Remedies are limited to actual out-of-pocket costs incurred; attorneys' fees and punitive, incidental, and consequential damages are waived to the fullest extent permitted by law.
