# 3. CONDITIONS OF PARTICIPATION & REWARD DELIVERY

- 3.1. The Program is valid only for Veeam users and authorized resellers in the United States (hereinafter known as the "Participant"). To be eligible for the Sweepstake, the Participant should complete the following steps:
- 3.1.1. Based in the United States and be a Veeam users and / or authorized resellers in the United States
- 3.1.2. How to enter:
- 3.1.2.1 REGISTER on the Sweepstake Website before Sweepstake Period ends. All eligible individuals who complete the registration associated with the Sweepstakes will be entered. Upon completing the registration, click the "Ok" button. Upon clicking the "Ok" button. The registration must be completed by 11:59:59pm PT on 4<sup>th</sup> March 2025.
- 3.1.2.2. ### 4. CONDITIONS OF PRIZE ACCEPTANCE
